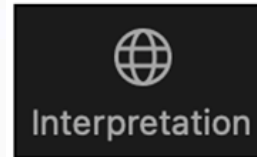

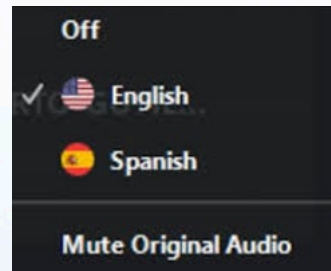
Accessing Zoom from a computer

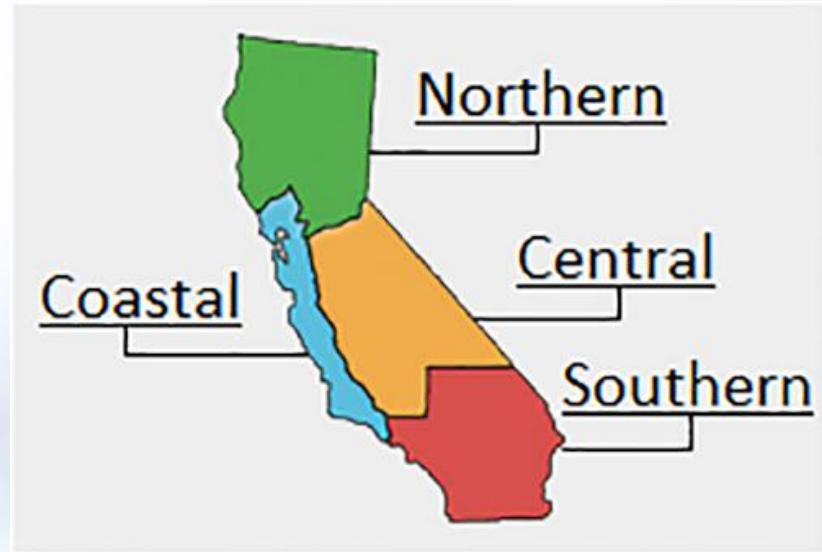

Sustainable Transportation Equity Project (STEP)

Multifaceted clean transportation and supporting projects to address community transportation needs and reduce VMT



Regional Clean Mobility Options Projects

Early pilots to provide shared mobility services



Clean Mobility in Schools (CMIS)

Clean transportation and education projects at K-12 public schools



Planning and Capacity Building (Planning)

Community-led planning and capacity building projects and dedicated, localized technical assistance and outreach

Purpose of Planning Projects

- Funds community-led planning and capacity building projects that increase transportation equity



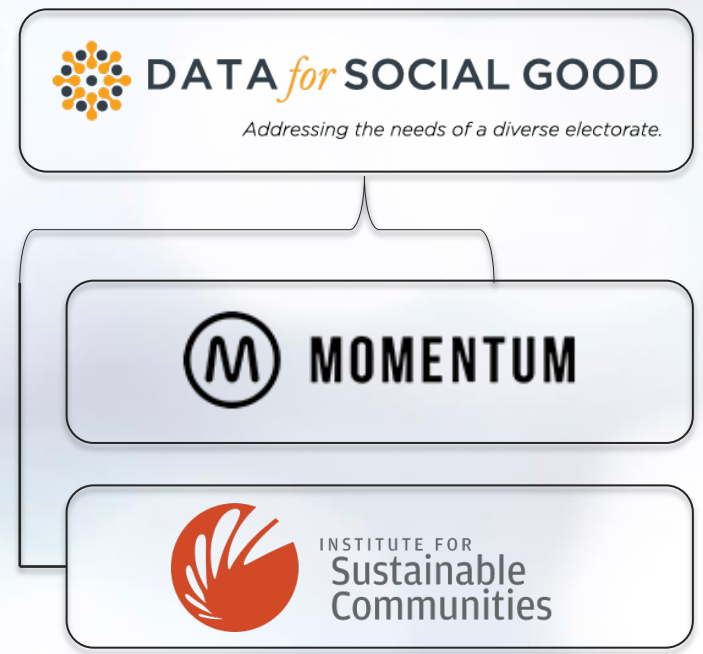
Current Status of Planning Projects

Fiscal Year	Funding Allocated	Number of Projects
2022-23	\$1.2 million \$5 million	<ul style="list-style-type: none"> • CMO, 12 CTNA's • Statewide Planning Administrator selected, and 7 Planning awards selected from competitive solicitations released in 2023
2023-24	\$10 million	<ul style="list-style-type: none"> • New Request for Applications (RFA) for 15+ projects and fully fund project from last RFA • Up to \$2.4 million for Statewide Administrator to oversee and provide outreach and support

Administration of Planning Projects

- Data for Social Good in partnership with Momentum and Institute for Sustainable Communities administers Planning grants
- Administrator team provides implementation support to Planning, Clean Mobility in Schools, and STEP grantees
- Clean Mobility Equity Alliance will be leveraged to support Project grantees

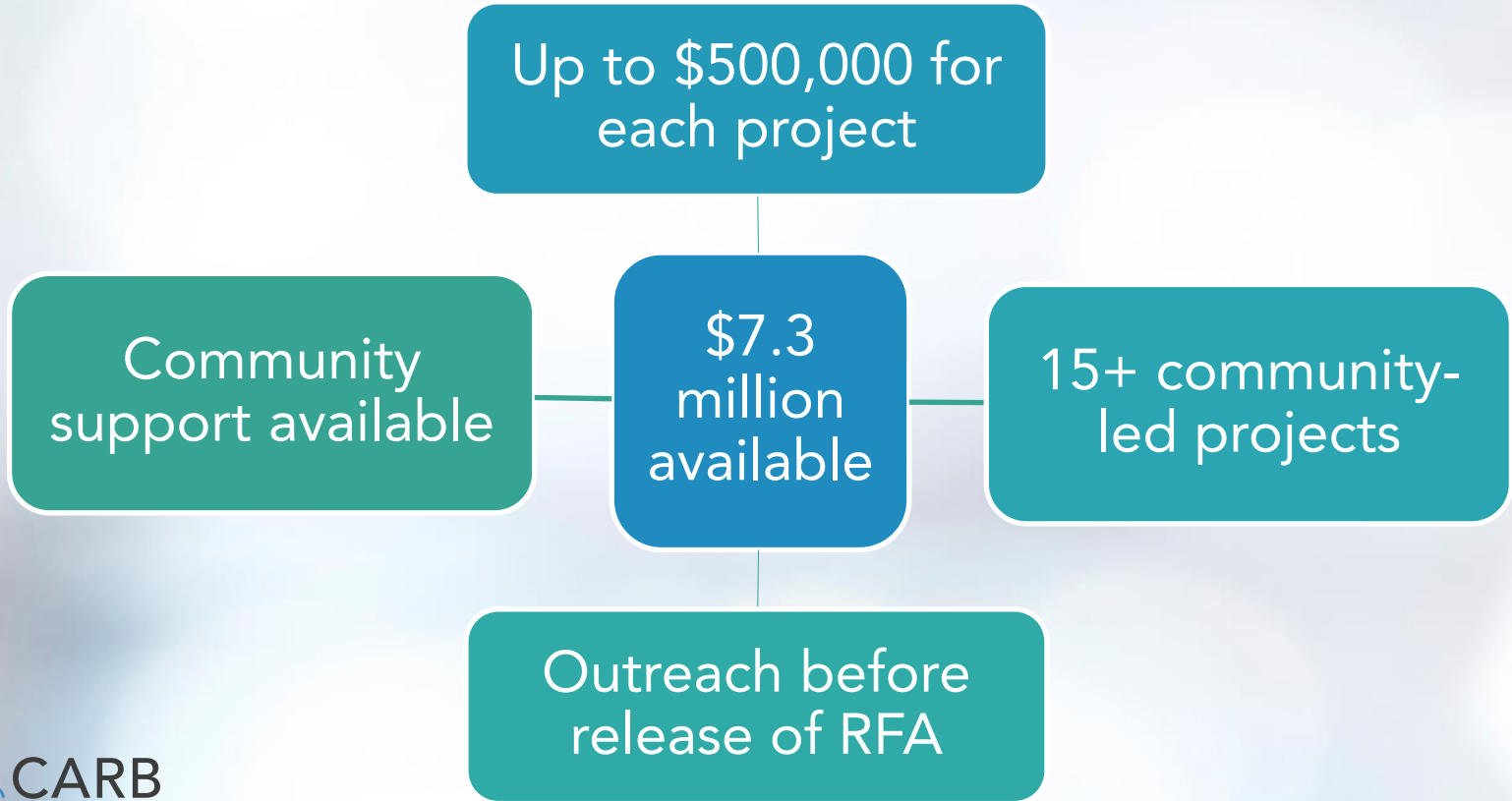

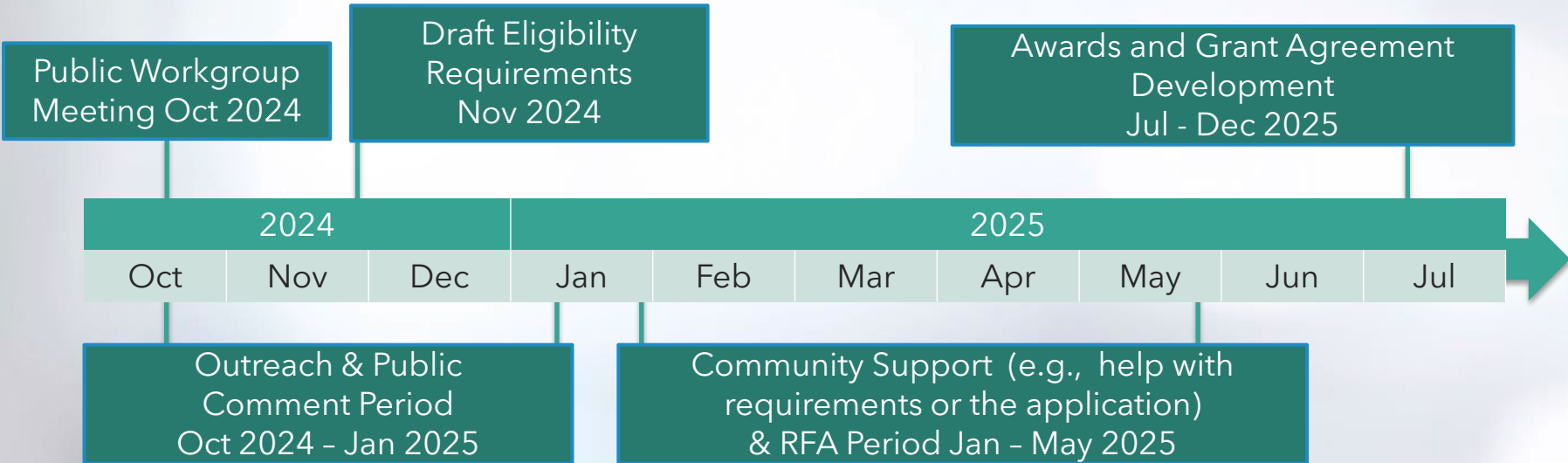
Lessons Learned from Previous Planning RFA

- Begin outreach and applicant support early
- Improve application support to include partnership building and tailored to applicants needs
- Simplify the two-phased application approach
- Give applicants more time to complete application
- Work with communities to make sure eligibility requirements are feasible for lower capacity organizations

Proposed Eligibility Requirements

- At least 50% of the project area is disadvantaged or low-income community census tracts, per [CalEnviroscreen 4.0](#)
- Eligible Lead Applicants include community-based organizations, local government, and Tribal governments
- Projects consists of partnerships between implementers and stakeholders with different skillsets and expertise

Proposed Eligible Projects

Project Category	Example Project Types
Clean transportation outreach, engagement, and capacity building	<ul style="list-style-type: none">• Community resource centers for clean transportation education and outreach• Community transportation needs assessments
Clean transportation, land use, and transportation equity plans	<ul style="list-style-type: none">• Plans and policies to support mode shift• Mobility plans (e.g., active transportation, safe routes to school, transit, multi-modal ZEV readiness, shared mobility)• Feasibility studies
Clean transportation workforce training and development	<ul style="list-style-type: none">• Job assistance and career development, apprenticeships, and pre-apprenticeship programs• On-the-job training for clean transportation staff

Proposed Application Sections

- Project community (detailed description and map)
- Applicants and partnership structure
- Project description and transportation equity
- Letters of commitment and support
- Scope and timeline
- Detailed budget (*updated template)
- Project benefit details
- Outreach and engagement
- Data collection, evaluation, and reporting
- Long-term sustainability

Proposed Scoring and Selection

- CARB/Interagency Review Panel
- Applicants must meet eligibility requirements to be scored
- Extra Points
 - Lead Applicant is a tribal government or a community-based organization
 - Project is in a rural community
 - Community has not received Clean Mobility Investment or Planning funds before
- CARB will select the highest scored applications until all available funds are awarded
