

The COVID Pandemic impacted Consumer Product Categories in Consumer Behavior and Supply Chain

Reporting Year 2020 Sales

PROS

• Supports a more robust assessment of category baseline sales activity

CONS

- Requires significant resources from Survey Respondents and CARB staff
- Justifies extension of additional Survey response time

Over-the-Counter (OTC) Drugs




