6. Costs associated with specific tasks –
 - A. The District staff time working under this grant from October 16, 2024, through October 31, 2024, included the following tasks:
 - i. Work on the emissions reporting regulation.
 - ii. Tracking Expedited BARCT rule SIP submittal.
 - iii. Forecasting pollutants and attending 1300/1400 calls.
 - iv. Administrative time and costs, including time management, recordkeeping, and billing.
7. How grant is being used to meet the goals of Assembly Bill 617 – the FRAQMD staff have used the AB 617 grant to improve forecasting capabilities in the district where a large portion of the population is part of a disadvantaged or low-income community. The improvements provide better information to the communities about current and forecasted emissions. The forecasting service enabled better meteorological forecasting capabilities and potential smoke impacts from the fires. The grant has also enabled the District to expand our public Wi-Fi access via Comcast during Board meetings and other public meetings so that our public meetings can be live streamed by the public or media. This increases accessibility to those that require translation services or are viewing remotely. This grant has also been used for District staff to participate in both the Emissions Inventory and BARCT working groups led by CARB. Participation in these groups included the review of draft documents, providing comments and feedback, and updating District management. The District adopted amendments to Rule 3.22 in accordance with the Expedited BARCT Schedule and is tracking

the approval process as EPA reviews the amended rule and considers for inclusion in the SIP.

8. Summary of work completed and in progress since the last progress report – No previous reports have been submitted.

9. Grant funds remaining and expended – The District requested a disbursement of \$88,430.75 on March 8, 2024. The District expended \$1,100.65 as of October 31, 2024. Please note that Management Time Hours (MT) cannot be split fractionally into parts, therefore. MT was billed starting on October 1st, 2024, through October 31st, 2024, to the previous grant (G22-CAPP-09). The remaining staff hours from 10/16/2024 through 10/31/2024 was billed to G23-CAPP-09.
