Particulate Matter (PM) Emission reductions from open burning are achieved through the program.

Provided roll offs dumpsters for green waste disposal in 3 communities in Lasssen County. Over 37 Tons of green waste was collected. Estimated PM Reduction of 0.1512 Ton at a Cost Effectivness of \$35,744.05/Ton.
