**Subject:** CARB Request: MPO target recommendation for SB 375 target update - by October 31, 2024

Good afternoon, and happy Monday everyone,

I hope this note finds you all well and that your summer has been a good one so far.

I'm writing to formally request MPO target recommendations as part of the SB 375 greenhouse gas reduction target update process. SB 375 requires CARB to set passenger vehicle GHG emissions reduction targets and update them no later than every eight years. The next update is due in 2026, and the update process includes MPO consultation, public involvement, CARB Board consultation and approval, and an environmental analysis.

1. PDF file with background on the target update process and schedule, and overview of the requested target recommendation and supporting information.
2. Excel file requesting key strategy metrics and exogenous factor values that support the GHG target recommendation calculation.
