## **REQUIRED SUPPORTING DOCUMENT CHECKLIST FOR ENGINE CHANGE VERIFICATION**

### **PURPOSE:**

Verification that a vehicle has had an engine change or engine swap, which is the installation of an engine that is different from the one which was originally installed in the vehicle, OR the engine and fuel type configuration needs verification

### **ATTENTION:**

A faded or missing ECL and/or illuminated MIL will result in the immediate failure of an inspection. If the MIL is ON, please repair and operate the vehicle to meet the readiness criteria. Please ensure the ECL is readable, or that a replacement has been ordered from an OEM parts supplier.
