Hi.

I'm concerned about the exclusion of long-distance train locomotives from the emissions reduction plans. The BNSF and UP lines through Southern California see over 100 trains per day, and each of those consist of heavily-polluting and smoking locomotives, often running at full power, running through residential neighborhoods.

Please consider modifying this agreement so that these trains require a "clean escort" of agreement-covered low-polluting engines when entering and travelling through metropolitan areas. Since both railroads have consolidated their lines through the area, residents living along those lines are unfairly exposed to the excessive concentration of pollution caused by the reduction in running lines.

Also, please consider working with the SCRRA and Amtrak to get the Green Goat into their fleets. Since SCRRA (Metrolink) locomotives and Amtrak Surfliner locomotives stop and go far more often than railroad locomotives, they would benefit greatly from hybrid technology and pollution controls.

Comment:

1. It is common practice for the major railroads to lease the locomotives from third party leasing companies. There may be more than 200 leased locomotives that are operated by BN and UP in California that do not bear their name on the locomotives. It is not clear if they are covered by this agreement

2. All the efforts that are part of the agreement bring only 20% reduction in PM. Even this 20% reduction is not a real number as most of the locomotives have already been equipped with idle reduction technology, or were already committed to installing them prior to the agreement. This agreement therefore creates not much new effort other than a huge regulatory system of monitoring, paper work, training, more administrative work. A lot of money it seems like will be spent on government personnel monitoring this program

3. The program as outlined is too weak and delivers very little public benefit at great administrative cost to both private and government.

4. Why not adopt South Coast AQMD's MOU Statewide and force all locomotives to comply with Tier II with early banking and credits as incentives. This will give 50% PM benefits, 60% NOx benefits. There are already technological developments in place to provide Tier II retrofit kits

In light of the above, we urge the Board to reject the agreement on the basis that it provides very little public benefits at great administrative burden. It is also based on misguided science, i.e. smoke and particulates are equivalent. I can understand a lay man saying this, but I have trouble seeing this inference in a regulatory document. Let me simply say that smoke and particulate matter are not equivalent.

In closing, we simply state that this agreement is based on too lenient measures, provides very little public benefit, is too bureaucratic in nature, and most of it is based on what the railroads are doing anyway. CARB has not presented what it is going to cost in CARB staff time and expense to implement and monitor this program. We must have the whole financial picture.

Thank you for accepting this testimony into the record of this proceeding.

CMTA supports the Memorandum of Understanding entered into between ARB and the railroads with regard to locomotive emissions. As a result of a voluntary and collaborative process, the MOU achieves 20% reduction in locomotive PM emissions statewide. Because of federal preemption over control of these emissions, the reductions are larger and sooner than could have been required by any California regulatory or legislative body.

In addition, CMTA supports the process ARB adopted to develop this MOU. By using a cooperative approach, California has avoided implementation delays due to disagreements over the State's legal authority over the affected companies. As a result, in the first 6 months of MOU implementation, the railroads have already made significant investments to reduce locomotive idling and smoking and increase the use of low sulfur fuel in California. The MOU has also stimulated plans to invest in new, cleaner technology, represented by the announcement to purchase 70 new switch engines for use in LA over the next two years.

CMTA advocates for both economic growth and a healthy environment. These goals require that government and industry work together to find solutions to environmental challenges. The railroad MOU represents such a solution and I urge you to keep the MOU in effect.
