EXECUTIVE ORDER D 288-173

Relating to Exemptions under
Section 27156 of the Vehicle Code

Transfer Flow, Inc.
Replacement Fill Pipes

Pursuant to the authority vested in the California Air Resources Board (CARB) by Vehicle Code (VC) Section 27156; and

Pursuant to the authority vested in the undersigned by Sections 39515 and 39516 of the Health and Safety Code and Executive Order G-14-012;

IT IS ORDERED AND RESOLVED: That installation of the Replacement Fill Pipes, manufactured by Transfer Flow, Inc. (TFI) of 1444 Fortress Street, Chico, California 95973, has been found not to reduce effectiveness of the applicable vehicle pollution control systems, and therefore, the Replacement Fill Pipes are exempt from the prohibitions in VC Section 27156 as listed in Exhibit A.

This Executive Order is based on an engineering evaluation of the impacts the Replacement Fill Pipes have on the vehicles' evaporative emissions, On-Board Refueling Vapor Recovery emissions, and On-Board Diagnostic II Systems.

This Executive Order is valid provided that installation instructions for the Replacement Fill Pipes do not recommend tuning the vehicles or engines to specifications different from those of the vehicle or engine manufacturers.

Changes made to the design or operating conditions of the Replacement Fill Pipes, as exempt by CARB, which adversely affect the performance of the vehicle's or engine's pollution control system, shall invalidate this Executive Order.

Marketing of the Replacement Fill Pipes using identification other than that shown in this Executive Order or for an application other than that listed in this Executive Order shall be prohibited unless prior approval is obtained from CARB.

Exemption of the Replacement Fill Pipes shall not be construed as an exemption to sell, offer for sale, or advertise any component of the Replacement Fill Pipes as individual devices.

This Executive Order shall not apply to any Replacement Fill Pipes advertised, offered for sale, sold with, or installed on a motor vehicle prior to or concurrent with transfer to an ultimate purchaser.

This Executive Order does not constitute any opinion as to the effect the use of the Replacement Fill Pipes may have on any warranty either expressed or implied by the vehicle or engine manufacturer.

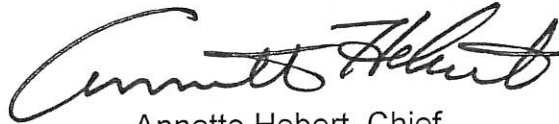
No claim of any kind, such as "Approved by the California Air Resources Board," may be made with respect to the action taken herein in any advertising or other oral or written communication.

In addition to the foregoing, CARB reserves the right in the future to review this Executive Order and the exemption provided herein to assure that the exempted add-on or modified part continues to meet the standards and procedures of California Code of Regulations, Title 13, Section 2222, et seq.

THIS EXECUTIVE ORDER DOES NOT CONSTITUTE A CERTIFICATION, ACCREDITATION, APPROVAL, OR ANY OTHER TYPE OF ENDORSEMENT BY CARB OF ANY CLAIMS OF THE APPLICANT CONCERNING ANTI-POLLUTION BENEFITS OR ANY ALLEGED BENEFITS OF TFI'S REPLACEMENT FILL PIPES.

Violation of any of the above conditions shall be grounds for revocation of this Executive Order. The Executive Order may be revoked only after a ten day written notice of intention to revoke the Executive Order, in which period the holder of the Executive Order may request in writing a hearing to contest the proposed revocation. If a hearing is requested, it shall be held within ten days of receipt of the request, and the Executive Order may not be revoked until a determination is made after a hearing that grounds for revocation exist.
