EXECUTIVE ORDER D-338-34

Relating to Exemptions Under Section 27156
of the Vehicle Code

Harley-Davidson
Screamin' Eagle Stage I Kits

Pursuant to the authority vested in the Air Resources Board by Section 27156 of the Vehicle Code; and

Pursuant to the authority vested in the undersigned by Section 39515 and Section 39516 of the Health and Safety Code and Executive Order G-45-9;

IT IS ORDERED AND RESOLVED: That the installation of the Screamin' Eagle Stage I Kits, marketed and manufactured by the Harley-Davidson Motor Company, 11800 W. Capitol Drive, P.O. Box 25527, Wauwatosa, Wisconsin 53225-5527 has been found not to reduce the effectiveness of the applicable vehicle pollution control system and, therefore, is exempt from the prohibitions of Section 27156 of the Vehicle Code for the 2002 model-year Harley-Davidson motorcycles originally equipped with the 1450cc fuel injected engine:

The Screamin' Eagle Stage I Kit, P/Ns 29773-02, includes the following main components: Screamin' Eagle high flow air cleaner and a new ECM calibration. The new ECM calibration, which is downloaded by Harley-Davidson dealers, requires the use of a scan tool.

The Screamin' Eagle Stage I Kit, P/Ns 29774-02, includes the following main components: Screamin' Eagle high flow air cleaner, larger bore cylinders to change bore from 3.75 to 3.875, larger bore pistons to accommodate cylinders, piston rings, gaskets, clutch spring, and a new ECM calibration. The new ECM calibration, which is downloaded by Harley-Davidson dealers, requires the use of a scan tool. The kit increases engine displacement from 1450 to 1550cc.

This Executive Order is valid provided that the installation instructions for the Screamin' Eagle Stage I Kits will not recommend tuning the vehicle to specifications different from those of the vehicle manufacturer.

This Executive Order shall not apply to any Harley-Davidson Screamin' Eagle Stage I Kits advertised, offered for sale, sold with, or installed on a motor vehicle prior to or concurrent with transfer to an ultimate purchaser.

Changes made to the design or operating conditions of the Screamin' Eagle Stage I Kits, as exempt by the Air Resources Board, which adversely affect the performance of the vehicle's pollution control system shall invalidate this Executive Order.

This Executive Order is granted based on the submitted emissions test data used for the 2002 Harley-Davidson 1550cc motorcycle certification, a configuration identical to the Screamin' Eagle Stage I Kit, part no. 29774-02:

Test results showed that the Screamin' Eagle Stage I Kit, when installed on the motorcycles, did not cause tailpipe emissions to exceed the applicable emission standard during a Cold Start CVS-75 Federal Test Procedure.

Marketing of the Screamin' Eagle Stage I Kits using any identification other than that shown in this Executive Order or marketing of the Screamin' Eagle Stage I Kits for an application other than those listed in this Executive Order shall be prohibited unless prior approval is obtained from the Air Resources Board. Exemption of the Screamin' Eagle Stage I Kits shall not be construed as exemption to sell, offer for sale, or advertise any component of the kit as an individual device.

This Executive Order does not constitute any opinion as to the effect the use of the Screamin' Eagle Stage I Kits may have on any warranty either expressed or implied by the vehicle manufacturer.

In addition to the foregoing, the ARB reserves the right in the future to review this Executive Order and the exemption provided herein to assure that the exempted add-on or modified part continues to meet the standards and procedures of Title 13, California Code of Regulations, Section 2222, et seq.

THIS EXECUTIVE ORDER DOES NOT CONSTITUTE A CERTIFICATION, ACCREDITATION, APPROVAL, OR ANY OTHER TYPE OF ENDORSEMENT BY THE AIR RESOURCES BOARD OF ANY CLAIMS OF THE APPLICANT CONCERNING ANTI-POLLUTION BENEFITS OR ANY ALLEGED BENEFITS OF HARLEY-DAVIDSON'S SCREAMIN' EAGLE STAGE I KITS.

No claim of any kind, such as "Approved by the Air Resources Board", may be made with respect to the action taken herein in any advertising or other oral or written communication.

Violation of any of the above conditions shall be grounds for revocation of this order. The order may be revoked only after a ten-day written notice of intention to revoke the order, in which period the holder of the order may request in writing a hearing to contest the proposed revocation. If a hearing is requested, it shall be held within ten days of receipt of the request and the order may not be revoked until a determination is made after the hearing that grounds for revocation exist.
