EXECUTIVE ORDER D-338-84
Relating to Exemptions Under Section 27156
of the Vehicle Code

Harley-Davidson Motor Company
Screamin' Eagle Stage IV Performance Kits
Part Numbers 92500060, 92500062, and 92500064

Pursuant to the authority vested in the Air Resources Board (ARB) by Vehicle Code (VC) Section 27156; and

Pursuant to the authority vested in the undersigned by Section 39515 and Section 39516 of the Health and Safety Code and Executive Order G-14-012;

IT IS ORDERED AND RESOLVED: That the installation of the Screamin' Eagle Stage IV Performance Kits, marketed and manufactured by the Harley-Davidson Motor Company, 3700 W. Juneau Avenue, Milwaukee, Wisconsin 53208 has been found not to reduce the effectiveness of the applicable vehicle pollution control system and, therefore, is exempt from the prohibitions of VC Section 27156 for 2017 model year Harley-Davidson Touring motorcycles with a 1746cc (107c.i.) or a 1868cc (114c.i.) and engine families HHDXC1.87AEF and HHDXC1.75AED.

The Harley-Davidson Screamin' Eagle Stage IV Performance Kits includes the following: Piston Kit, Cylinder Head Kit, SE8-515 Camshaft, fuel injectors, and a 64mm Throttle Body Kit. A new ECM calibration is also included; there are no user adjustments on the new ECM calibration. No other changes are required for proper installation.

Changes made to the design or operating conditions of the Screamin' Eagle Stage IV Performance Kits, as exempted by ARB, which adversely affect the performance of the motorcycle's pollution control system shall invalidate this Executive Order.

Marketing of the Screamin' Eagle Stage IV Performance Kits using any identification other than that shown in this Executive Order or marketing of the Screamin' Eagle Stage IV Performance Kits for an application other than those listed in this Executive Order shall be prohibited unless prior approval is obtained from the ARB.

This Executive Order does not constitute any opinion as to the effect the use of these Screamin' Eagle Stage IV Performance Kits may have on any warranty either expressed or implied by the Harley-Davidson Motor Company.

Harley-Davidson submitted emission test results on a 2017 model year Touring motorcycle (water cooled) modified with the Screamin' Eagle Stage IV Performance Kit, Part No. 92500064.

The motorcycle met the applicable emission standards when tested using the Cold-Start CVS-75 Federal Test Procedure (FTP) test cycle. Results from emissions testing conducted at the Harley-Davidson Motor Company's emissions laboratory, located in Milwaukee, Wisconsin, are shown below (in grams per kilometer).

No claim of any kind, such as "Approved by the Air Resources Board", may be made with respect to the action taken herein in any advertising or other oral or written communication.

Violation of any of the above conditions shall be grounds for revocation of this order. The order may be revoked only after a ten-day written notice of intention to revoke the order, in which period the holder of the order may request in writing a hearing to contest the proposed revocation. If a hearing is requested, it shall be held within ten days of receipt of the request and the order may not be revoked until a determination is made after the hearing that grounds for revocation exist.
