EXECUTIVE ORDER D-343
Relating to Exemptions Under Section 27156
of the Vehicle Code

WORLD PRODUCTS, INC.
WINDSOR & WINDSOR JR. CYLINDER HEADS

Pursuant to the authority vested in the Air Resources Board by Section 27156 of the Vehicle Code; and

Pursuant to the authority vested in the undersigned by Sections 39515 and 39516 of the Health and Safety Code and Executive Order G-45-5;

IT IS ORDERED AND RESOLVED: That the installation of the Windsor and Windsor Jr. cast iron cylinder heads, part nos. 5302A, 5302B, 5303A, and 5303B manufactured by World Products, Inc. of 80 Trade Zone Court, Ronkonkoma, New York 11779, have been found not to reduce the effectiveness of the applicable vehicle pollution control system and, therefore, are exempt from the prohibitions of Section 27156 of the Vehicle Code for 1994 and older Ford Motor Company vehicles with either a 289, 302, or 351 CID V-8 gasoline engine.

This Executive Order is valid provided that installation instructions for the Windsor and Windsor Jr. Cylinder Heads will not recommend tuning the vehicle to specifications different from those of the vehicle manufacturer.

Changes made to the design or operating conditions of the cylinder heads, as exempt by the Air Resources Board, which adversely affect the performance of a vehicle's pollution control system shall invalidate this Executive Order.

Marketing of these cylinder heads using any identification other than that shown in this Executive Order or marketing of the cylinder heads for an application other than those listed in this Executive Order shall be prohibited unless prior approval is obtained from the Air Resources Board. This Executive Order does not constitute any opinion as to the effect the use of this cylinder heads may have on any warranty either expressed or implied by the vehicle manufacturer.

THIS EXECUTIVE ORDER DOES NOT CONSTITUTE A CERTIFICATION, ACCREDITATION, APPROVAL, OR ANY OTHER TYPE OF ENDORSEMENT BY THE AIR RESOURCES BOARD OF CLAIMS OF THE APPLICANT CONCERNING ANTI-POLLUTION BENEFITS OR ANY ALLEGED BENEFITS OF WORLD PRODUCTS, INC.'S WINDSOR & WINDSOR JR. CYLINDER HEADS.

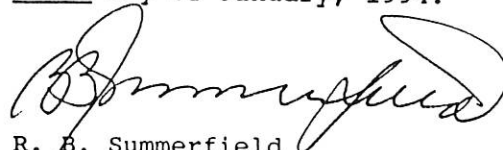

The order may be revoked only after ten day written notice of intention to revoke the order, in which period the holder of the order may request in writing a hearing to contest the proposed revocation. If a hearing is requested, it shall be held within ten days of receipt of the request and the order may not be revoked until a determination after hearing that grounds for revocation exist.
