EXECUTIVE ORDER D-355-6
Relating to Exemptions Under Section 27156
of the Vehicle Code

S&S CYCLE, INC.
50-STATE LEGAL HOT SET UP KIT

Pursuant to the authority vested in the Air Resources Board by Section 27156 of the Vehicle Code; and

Pursuant to the authority vested in the undersigned by Section 39515 and Section 39516 of the Health and Safety Code and Executive Order G-45-9;

IT IS ORDERED AND RESOLVED: That the installation of the 50-State Legal Hot Set Up Kit manufactured and marketed by S&S Cycle, Inc. of P.O. Box 215, 14025 County Hwy G, Viola, Wisconsin 54664 has been found not to reduce the effectiveness of required motor vehicle pollution control devices and, therefore, is exempt from the prohibitions of Section 27156 of the California Vehicle Code for 1970 to 2000 Harley-Davidson motorcycles originally equipped with a carbureted, Big Twin-Evolution engine as listed.

The 50-State Legal Hot Set Up Kit includes the following main components: New carburetor, air filter housing with carbon element, intake manifold, connecting rods, pistons, camshaft, and cylinder heads. Part nos. 32-2096 and 32-2089 do not include new cylinder heads as part of the kit. The stock Harley-Davidson crankcase is retained. Exhibit A lists the actual part numbers of supplied components.

This Executive Order shall not apply to any S&S Cycle, Inc. 50-State Legal Hot Set Up Kit advertised, offered for sale, sold with, or installed on a new motor vehicle prior to or concurrent with transfer to an ultimate purchaser.

This Executive Order is valid provided that the installation instructions for the 50-State Legal Hot Set Up Kit will not recommend tuning the vehicle to specifications different from those of the vehicle manufacturer.

Changes made to the design or operating conditions of the device, as exempted by the Air Resources Board (ARB), that adversely affect the performance of a vehicle's pollution control system shall invalidate this Executive Order.

Marketing of this device using any identification other than that shown in this Executive Order or marketing of this device for an application other than those listed in this Executive Order shall be prohibited unless prior approval is obtained from the ARB.

This Executive Order does not constitute any opinion as to the effect that the use of this device may have on any warranty either expressed or implied by the vehicle manufacturer.

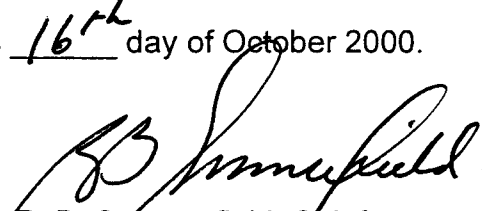
This exemption is issued based on emission test results provided by S&S Cycle, Inc. for its new vehicle certification of the 1564cc (96cid) replacement engine. Submitted emissions test data from S&S Cycle, Inc. showed that the 96cid replacement engine was below the applicable emission standards for all 2000 and older Harley-Davidson motorcycles equipped with the 1340cc carbureted engine. The 50-State Legal Hot Set Up Kit, part no. 90-0096 which is the worst case modification, is identical to the S&S Cycle, Inc.'s 1564cc (96cid) replacement engine, excluding the original Harley-Davidson crankcase which is retained. A similar emissions impact is expected when any of the above 50 State Legal Hot Set Up Kits are installed on the applicable vehicles.

THIS EXECUTIVE ORDER DOES NOT CONSTITUTE A CERTIFICATION, ACCREDITATION, APPROVAL, OR ANY OTHER TYPE OF ENDORSEMENT BY THE AIR RESOURCES BOARD OF ANY CLAIMS OF THE APPLICANT CONCERNING ANTI-POLLUTION BENEFITS OR ANY ALLEGED BENEFITS OF S&S CYCLE, INC.'S 50-STATE LEGAL HOT SET UP KIT.

No claims of any kind, such as "Approved by the Air Resources Board" may be made with respect to the action taken herein in any advertising or other oral or written communication.

Violation of any of the above conditions shall be grounds for revocation of this order. The order may be revoked only after ten day written notice of intention to revoke the order, in which period the holder of the order may request in writing a hearing to contest the proposed revocation. If a hearing is requested, it shall be held within ten days of receipt of the request and the order may not be revoked until a determination is made after the hearing that grounds for revocation exist.
