EXECUTIVE ORDER D-362
Relating to Exemptions Under Section 27156
of the Vehicle Code

ROTARY PERFORMANCE
CAMDEN SUPERCHARGER KIT #99140-05

Pursuant to the authority vested in the Air Resources Board (ARB) by Section 27156 of the Vehicle Code; and

Pursuant to the authority vested in the undersigned by Sections 39515 and 39516 of the Health and Safety Code and Executive Order G-45-5;

IT IS ORDERED AND RESOLVED: That the installation of the add-on Camden Supercharger Kit #99140-05 manufactured by Camden Superchargers of 401-M East Breaker Lane, Austin, Texas 78753, and distributed by Rotary Performance of 311 East Buckingham Road, Suite 3, Garland, Texas 75040, has been found not to reduce the effectiveness of the required motor vehicle pollution control system and, therefore, is exempt from the prohibitions of Section 27156 of the Vehicle Code for installation on 1990-92 model-year Mazda MX-5 Miata equipped with a 1.6 liter fuel injected gasoline engine using a 5.5 inch crankshaft pulley and a 4.25 inch supercharger pulley.

Modifications of the emissions control components include addition of Auxiliary Fuel Injector and Auxiliary Injector Controller, relocation of the throttle body, fuel pressure regulator vacuum reference signal from intake manifold, addition of tee-fitting in the fuel line connecting to the Auxiliary Fuel Injector and addition of air temperature sensor mounted under hood inside driver's fender area and connected to factory sensor located in the air flow meter.

This Executive Order is valid provided that the installation instructions for the supercharger kit will not recommend tuning the vehicle to specifications different from those submitted by Rotary Performance.

Changes made to the design or operating conditions of the supercharger kit, as exempt by the ARB, which adversely affect the performance of a vehicle's pollution control system shall invalidate this Executive Order.

Marketing of the supercharger kit using any identification other than that shown in this Executive Order or marketing of the supercharger kit for an application other than those listed in this Executive Order shall be prohibited unless prior approval is obtained from the ARB. Exemption of the supercharger kit shall not be construed as exemption to sell, offer for sale, or advertise any component of the kit as an individual device.

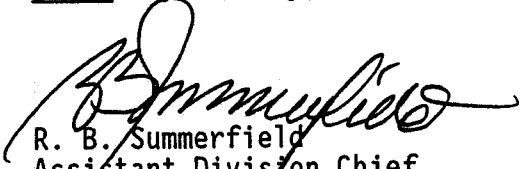
This Executive Order does not constitute any opinion as to the effect that the use of the supercharger kit may have on any warranty either expressed or implied by the vehicle manufacturer.

THIS EXECUTIVE ORDER DOES NOT CONSTITUTE A CERTIFICATION, ACCREDITATION, APPROVAL, OR ANY OTHER TYPE OF ENDORSEMENT BY THE ARB OF CLAIMS OF THE APPLICANT CONCERNING ANTI-POLLUTION BENEFITS OR ANY ALLEGED BENEFITS OF ROTARY PERFORMANCE'S CAMDEN SUPERCHARGER KIT #99140-05.

No claim of any kind, such as "Approved by the ARB" may be made with respect to the action taken herein in any advertising or other oral or written communication.

Violation of any of the above conditions shall be grounds for revocation of this order. The order may be revoked only after ten day written notice of intention to revoke the order, in which period the holder of the order may request in writing a hearing to contest the proposed revocation. If a hearing is requested, it shall be held within ten days of receipt of the request and the order may not be revoked until a determination after hearing that grounds for revocation exist.
