



EXECUTIVE ORDER D-431-5

Relating to Exemptions Under Section 27156
of the California Vehicle Code

Ford Motor Company
Eco Boost Power Pack Calibration

Pursuant to the authority vested in the California Air Resources Board by Section 27156 of the Vehicle Code; and

Pursuant to the authority vested in the undersigned by Section 39515 and Section 39516 of the Health and Safety Code and Executive Order G-19-095;

IT IS ORDERED AND RESOLVED: That installation of the Eco Boost Power Pack Calibration, manufactured and marketed by Ford Motor Company, 1800 Fairlane Drive Allen Park, Michigan 48101, has been found not to reduce the effectiveness of the applicable vehicle pollution control systems and, therefore, is exempt from the prohibitions of Section 27156 of the Vehicle Code for the vehicle applications listed in Exhibit A.

The Eco Boost Power Pack Calibration optimizes engine performance for operation using premium fuel. The new calibration is loaded into the ECU using the ProCal 3 or ProCal 4 programmer. Tire size and gear ratio can be adjusted to correct the speedometer. No other user adjustment is provided. Only one calibration is available for each vehicle.

This Executive Order is valid provided that the installation instructions for the Eco Boost Power Pack Calibration will not recommend tuning the vehicle to specifications different from those specified by Ford Motor Company.

Changes made to the design or operating conditions of the Eco Boost Power Pack Calibration, as exempted by the California Air Resources Board, that adversely affect the performance of the vehicle's emission control system shall invalidate this Executive Order.

This Executive Order shall not apply to any Eco Boost Power Pack Calibration advertised, offered for sale, sold with, or installed on a new motor vehicle prior to or concurrent with transfer to an ultimate purchaser.

Marketing of the Eco Boost Power Pack Calibration using any identification other than those shown in this Executive Order or marketing of the Eco Boost Power Pack Calibration for an application other than those listed in this Executive Order shall be prohibited unless prior approval is obtained from the California Air Resources Board.

This Executive Order does not constitute any opinion as to the effect the use of the Eco Boost Power Pack Calibration may have on any warranty, either expressed or implied by the vehicle manufacturer; or compliance with any other state, federal, or local law, such as safety equipment requirements or noise limitations.

Exemption of the Eco Boost Power Pack Calibration shall not be construed as an exemption to sell, offer for sale, or advertise any component of the assembly as individual devices.

This Executive Order is granted based on information submitted by Ford Motor Company, including emissions test data.

The California Air Resources Board reserves the right in the future to review this Executive Order and the exemption provided herein to ensure that the exempted add-on or modified part continues to meet the standards and procedures of Title 13, California Code of Regulations, Section 2222, et seq. Further, if test results or other evidence provides the California Air Resources Board with reason to suspect that the Eco Boost Power Pack Calibration will affect the durability of emission control systems, Ford Motor Company shall be required to submit durability data to show that the durability of vehicle emission control systems are not, in fact, affected and/or that the add-on or modified part demonstrates adequate durability.

THIS EXECUTIVE ORDER DOES NOT CONSTITUTE A CERTIFICATION, ACCREDITATION, APPROVAL, OR ANY OTHER TYPE OF ENDORSEMENT BY THE CALIFORNIA AIR RESOURCES BOARD OF ANY CLAIMS OF THE APPLICANT CONCERNING ANTI-POLLUTION BENEFITS OR ANY ALLEGED BENEFITS OF THE ECO BOOST POWER PACK CALIBRATION.

No claim of any kind, such as "Approved by the California Air Resources Board", may be made with respect to the action taken herein in any advertising or other oral or written communication.

Violation of any of the above conditions shall be grounds for revocation of this order. The order may be revoked only after a ten-day written notice of intention to revoke the order, in which period the holder of the order may request in writing a hearing to contest the proposed revocation. If a hearing is requested, it shall be held within ten days of receipt of the request and the order may not be revoked until a determination is made after the hearing that grounds for revocation exist.
