EXECUTIVE ORDER D-436-10

Relating to Exemptions Under Section 27156
of the Vehicle Code

Steve Millen Sportparts, Inc.
Stillen Supercharger Kit

Pursuant to the authority vested in the Air Resources Board by Section 27156 of the Vehicle Code; and

Pursuant to the authority vested in the undersigned by Section 39515 and Section 39516 of the Health and Safety Code and Executive Order G-02-003;

IT IS ORDERED AND RESOLVED: That the installation of the Stillen Supercharger Kit, manufactured and marketed by Steve Millen Sportparts, Inc., 3176 Airway Avenue, Costa Mesa, California 92626 has been found not to reduce the effectiveness of the applicable vehicle pollution control system and, therefore, is exempt from the prohibitions of Section 27156 of the Vehicle Code for the following 3.5L Nissan/Infiniti vehicle applications listed, excluding the following 2004 model-year LEV II LEV test groups: 4NSXV03.5G7C, 4NSXT03.5G7A and 4NSXV03.5G7A.

Model-Year Applications

2003	Altima, FX35, Murano, Maxima, Pathfinder, QX4, 350Z, G35, I35
2004	Altima, Frontier, Pathfinder, Xterra, FX35, 350Z, G35, I35

The Stillen Supercharger Kit consists of a Magnuson Products, Inc. supercharger assembly that is rated at a maximum boost of 6.1 psi. at 6500 rpms using a 2.2" diameter pulley. The kit also includes an upper intake manifold, a supercharger bypass valve, an add-on fuel injector that uses a metal fuel rail, an intercooler, and a stand alone fuel management unit to operate the additional fuel injector. Installation of the supercharger kit requires the rerouting of the positive crankcase ventilation hose. All supplied hoses and lines are SAE30R9 which is rated at 15 gm/m2/24hrs. The kit retains the stock air cleaner housing.

This Executive Order is valid provided that the installation instructions for the Stillen Supercharger Kit will not recommend tuning the vehicle to specifications different from those submitted by the device manufacturer.

This Executive Order shall not apply to any Steve Millen Sportparts, Inc.'s Stillen Supercharger Kit advertised, offered for sale, sold with, or installed on a new motor vehicle prior to or concurrent with transfer to an ultimate purchaser.

Changes made to the design or operating conditions of the Stillen Supercharger Kit, as exempt by the Air Resources Board, which adversely affect the performance of the vehicle's pollution control system shall invalidate this Executive Order.

Marketing of the Stillen Supercharger Kit using any identification other than that shown in this Executive Order or marketing of the Stillen Supercharger Kit for an application other than those listed in this Executive Order shall be prohibited unless prior approval is obtained from the Air Resources Board.

Exemption of the Stillen Supercharger Kit shall not be construed as exemption to sell, offer for sale, or advertise any component of the kit as an individual device.

This Executive Order does not constitute any opinion as to the effect the use of the Stillen Supercharger Kit may have on any warranty either expressed or implied by the vehicle manufacturer.

This Executive Order is granted based on emissions test data generated on a 2003 Nissan 350Z certified to the Low-Emission Vehicle (LEV) emission standards. Emission levels of the modified vehicle met the applicable emission standards over the Cold-Start CVS-75 Federal Test Procedure (FTP) and the Supplemental Federal Test Procedure (US06/SC03) test cycles. Results are in grams per mile with deterioration factors added to CVS-75 results:

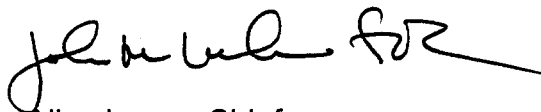
This Executive Order is also based on an On-Board Diagnostic II (OBD II) test conducted on the same test vehicle. Test data showed that the supercharger when installed on the vehicle did not affect the vehicle's ability to perform its OBD II monitoring.

THIS EXECUTIVE ORDER DOES NOT CONSTITUTE A CERTIFICATION, ACCREDITATION, APPROVAL, OR ANY OTHER TYPE OF ENDORSEMENT BY THE AIR RESOURCES BOARD OF ANY CLAIMS OF THE APPLICANT CONCERNING ANTI-POLLUTION BENEFITS OR ANY ALLEGED BENEFITS OF STEVE MILLEN SPORTPARTS, INC.'S STILLEN SUPERCHARGER KIT.

No claim of any kind, such as "Approved by the Air Resources Board", may be made with respect to the action taken herein in any advertising or other oral or written communication.

Violation of any of the above conditions shall be grounds for revocation of this order. The order may be revoked only after a ten-day written notice of intention to revoke the order, in which period the holder of the order may request in writing a hearing to contest the proposed revocation. If a hearing is requested, it shall be held within ten days of receipt of the request and the order may not be revoked until a determination is made after the hearing that grounds for revocation exist.
