

## **EXECUTIVE ORDER D-730-5**

## Relating to Exemptions under Section 27156 of the California Vehicle Code

## Bullet Proof Diesel BulletProof EGR Cooler 6.7L Ford Power Stroke

Pursuant to the authority vested in the California Air Resources Board by Section 27156 of the Vehicle Code; and

Pursuant to the authority vested in the undersigned by Section 39515 and Section 39516 of the Health and Safety Code and Executive Order G-19-095;

IT IS ORDERED AND RESOLVED: That installation of the BulletProof EGR Cooler 6.7L Ford Power Stroke, manufactured by Bullet Proof Diesel, 4245 East Palm Street, Mesa, Arizona 85215, has been found not to reduce the effectiveness of the applicable vehicle pollution control systems and, therefore, is exempt from the prohibitions of Section 27156 of the Vehicle Code for the vehicle applications listed in Exhibit A.

The BulletProof EGR Cooler 6.7L Ford Power Stroke is a direct replacement for the factory EGR Cooler, that has the same fit and functionality as the factory unit. The BulletProof EGR Cooler 6.7L Ford Power Stroke features the H-Core design technology that comprises of helical tube bundles for exhaust gas cooling during recirculation. It has no mechanical or electrical user adjustments, and no changes are made to any component of the stock engine for installation, including engine calibration, or any other component of the exhaust system.

This Executive Order is granted based on exhaust emission testing in the modified configuration using the Federal Test Procedure (FTP), Highway Fuel Economy Test (HWFET), and an On-Board Diagnostics II (OBD II) examination. Emission test results on a modified 2020 6.7L Ford F350 Turbo Diesel (LFMXD06.771D; LEV3 ULEV270) demonstrated that the exhaust emissions met the vehicle's applicable emission standards, and the vehicle's ability to perform its On-Board Diagnostics II monitoring was not affected.

Exemption of the BulletProof EGR Cooler 6.7L Ford Power Stroke shall not be construed as an exemption to sell, offer for sale, or advertise any component of the assembly as individual devices.

This Executive Order shall not apply to any BulletProof EGR Cooler 6.7L Ford Power Stroke advertised, offered for sale, sold with, or installed on a new motor vehicle prior to or concurrent with transfer to an ultimate purchaser.

This Executive Order is valid provided that the installation instructions for the BulletProof EGR Cooler 6.7L Ford Power Stroke will not recommend tuning the vehicle to specifications different from those of the vehicle manufacturer.

Changes made to the design or operating conditions of the BulletProof EGR Cooler 6.7L Ford Power Stroke, as exempted by the California Air Resources Board, that adversely affect the performance of the vehicle's emission control system shall invalidate this Executive Order.

Marketing of the BulletProof EGR Cooler 6.7L Ford Power Stroke using any identification other than those shown in this Executive Order or marketing of the BulletProof EGR Cooler 6.7L Ford Power Stroke for an application other than those listed in this Executive Order shall be prohibited unless prior approval is obtained from the California Air Resources Board.

In addition to the foregoing, the California Air Resources Board reserves the right in the future to review this Executive Order and the exemption provided herein to assure that the exempted add-on or modified part continues to meet the standards and procedures of Title 13, California Code of Regulations, Section 2222, et seq.

This Executive Order does not constitute any opinion as to the effect the use of the BulletProof EGR Cooler 6.7L Ford Power Stroke may have on any warranty either expressed or implied by the vehicle manufacturer.

No claim of any kind, such as "Approved by the California Air Resources Board", may be made with respect to the action taken herein in any advertising or other oral or written communication.

THIS EXECUTIVE ORDER DOES NOT CONSTITUTE A CERTIFICATION, ACCREDITATION, APPROVAL, OR ANY OTHER TYPE OF ENDORSEMENT BY THE CALIFORNIA AIR RESOURCES BOARD OF ANY CLAIMS OF THE APPLICANT CONCERNING ANTI-POLLUTION BENEFITS OR ANY ALLEGED BENEFITS OF BULLETPROOF EGR COOLER 6.7L FORD POWER STROKE.

Violation of any of the above conditions shall be grounds for revocation of this order. The order may be revoked only after a ten-day written notice of intention to revoke the order, in which period the holder of the order may request in writing a hearing to contest the proposed revocation. If a hearing is requested, it shall be held within ten days of receipt of the request and the order may not be revoked until a determination is made after the hearing that grounds for revocation exist.
