



EXECUTIVE ORDER D-784-2

Relating to Exemptions Under Section 27156
of the California Vehicle Code

Derive Efficiency, LLC
X3 Economizer, Part No. 3430EO

Pursuant to the authority vested in the California Air Resources Board by Section 27156 of the Vehicle Code; and

Pursuant to the authority vested in the undersigned by Section 39515 and Section 39516 of the Health and Safety Code and Executive Order G-14-012;

IT IS ORDERED AND RESOLVED: That the installation of the X3 Economizer, manufactured and marketed by Derive Efficiency, LLC, 4150 West Church Street, Suite 1024, Sanford, Florida 32771, has been found not to reduce the effectiveness of the applicable vehicle pollution control systems and, therefore, is exempt from the prohibitions of Section 27156 of the Vehicle Code for the following vehicle applications listed in Exhibit A.

The X3 Economizer, part number 3430EO, is a hand held programmer designed to reprogram the FLASH memory chip located in the vehicle's ECU module. The X3 Economizer's design options are to moderate driver's operating behavior by modifying drive pedal characteristics and limiting the vehicle's top speed. The X3 Economizer data files cannot be modified by the end user.

This Executive Order is valid provided that the installation instructions for the X3 Economizer will not recommend tuning the vehicle to specifications different from those of the vehicle manufacturer.

Changes made to the design or operating conditions of the X3 Economizer as exempt by the California Air Resources Board, which adversely affect the performance of the vehicle's pollution control system shall invalidate this Executive Order.

Marketing of the X3 Economizer using any identification other than that shown in this Executive Order or marketing of the X3 Economizer for an application other than those listed in this Executive Order shall be prohibited unless prior approval is obtained from the California Air Resources Board.

This Executive Order does not constitute any opinion as to the effect the use of the X3 Economizer may have on any warranty either expressed or implied by the vehicle manufacturer.

This exemption is issued based on submitted emissions test data from both the SEMA Garage located in Diamond Bar, California and Automotive Testing and Development Services, Inc. located in Ontario, California, on a 5.3L 2017 model year GMC Yukon, certified to the LEV III ULEV 125 emission standards and tested using the Cold-Start CVS-75 Federal Test Procedure (FTP) test cycle, Supplemental Federal Test Procedure (SFTP US06/SC03), and the Highway Fuel Economy Test (HWFET) test cycles.

Test results showed that the X3 Economizer, part number 3430EO when installed on the vehicle did not cause exhaust emissions to exceed the applicable emission levels during the FTP, SFTP, and HWFET test cycles. This Executive Order is also based on the On-Board Diagnostic II (OBD II) testing conducted on the same test vehicle. The X3 Economizer when installed on the test vehicle did not affect the vehicle's ability to perform its OBD II monitoring. Similar results would be expected when installed on the other vehicles listed.

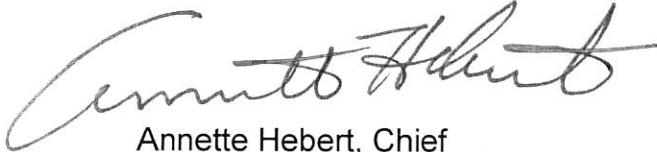

Violation of any of the above conditions shall be grounds for revocation of this order. The order may be revoked only after a ten-day written notice of intention to revoke the order, in which period the holder of the order may request in writing a hearing to contest the proposed revocation. If a hearing is requested, it shall be held within ten days of receipt of the request and the order may not be revoked until a determination is made after the hearing that grounds for revocation exist.
