


Air Quality: China

- 2013 MOUs to cooperate on Air Quality
- Active engagement with Beijing Environmental Protection Bureau
 - Beijing closed coal power plants after many visits to CARB
 - Last coal-fired power plant in city closed in March 2017

Air Quality: Mexico, cont.


- California-Mexico MOU, 2014
 - Joint, two-year study of particulate matter (PM) in Mexicali, Mexico
 - Donated surplus air monitoring equipment
 - CARB provides technical expertise and laboratory analysis support
- New air quality agency to be launched in Nuevo Leon
 - Inspired by the California model

International Visitors: Programs of Interest

Nearly half of visitors in 2016 interested in

climate programs

- AB 32 has national and international impact
- California's climate programs serve as model for world



Climate: Mexico

- Mexico: Climate Change Working Group
 - Focus on monitoring, reporting, and verification (MRV) of GHG emissions
 - Exchanging best practices on managing forests for carbon sequestration



Climate: China MOU

- China: NDRC and Provincial Governments
 - Knowledge exchange regarding ETS design
 - China's national ETS expected to launch in 2017

 - International Carbon Action Partnership (ICAP)
 - Partnership for Market Readiness (PMR)
 - Governors' Climate and Forests Task Force (GCF)

- Québec California Letter of Intent for Collaboration on Zero Emission Vehicles
 - Regular engagement on policies to promote ZEVs
- International ZEV Alliance
 - Strive to make all passenger vehicle sales in jurisdictions ZEVs as fast as possible, and no later than 2050

Pacific Coast Collaborative

- Pacific Coast Action Plan on Climate & Energy: British Columbia, Oregon & Washington
 - Lead Climate Change Policy
 - Sync Targets for GHG Reductions
 - Clean Transportation
 - Low Carbon Fuel Standard


