# Arie Haagen-Smit, Ph.D.



Mobile Laboratory

- Professor at California Institute of Technology
- Linked Los Angeles smog to automobiles
- “Father” of air pollution control
- CARB’s first Chair in 1968
- Awarded National Medal of Science in 1973
