18 The Executive Officer of Air Resources Board (ARB) will conduct a public hearing  
19 pursuant to Health and Safety Code section 42316, subdivision (b), at the time and place  
20 noted below. At the hearing, the Executive Officer will consider an appeal filed by the  
21 City of Los Angeles (the City), acting by and through its Department of Water and Power,  
22 challenging the validity of the Great Basin Unified Air Pollution Control District's (the  
23 District) Revised Final 2011 Supplemental Control Requirements Determination (2011  
24 SCRD).

14 positions set forth by the City and the District.
- 15 g. Up to 15 minutes will be allotted for comments from interested members of the  
16 public following the presentations by the parties and ARB staff.


