**Resolution 07-6**

January 25, 2007

Agenda Item No: 07-1-6

WHEREAS, the Legislature has passed and the Governor has signed the California Global Warming Solutions Act of 2006 (the Act), which designates the Air Resources Board (ARB) as the State agency charged with monitoring and regulating sources of emissions of greenhouse gases that cause global warming;

WHEREAS, the Act further directs the Board to adopt rules and regulations in an open public process to achieve the maximum technologically feasible and cost-effective greenhouse gas emission reductions;

WHEREAS, section 38591(a) of the Health and Safety Code directs the Board to convene an Environmental Justice Advisory Committee of at least three members by July 1, 2007, to advise the Board in developing the scoping plan of emission reduction measures and any other pertinent matter in implementing the Act;

WHEREAS, section 38591(a) of the Health and Safety Code further directs that the Environmental Justice Advisory Committee shall be comprised of representatives from communities in the state with the most significant exposure to air pollution, including, but not limited to, communities with minority populations or low-income populations or both;

WHEREAS, section 38591(b) of the Health and Safety Code directs the Board to appoint the Environmental Justice Advisory Committee members from nominations received from environmental justice organizations and community groups;

WHEREAS, section 38591(d) of the Health and Safety Code directs the Board to appoint an Economic and Technology Advancement Advisory Committee to advise the Board on activities that will facilitate investment in and implementation of technological research and development opportunities, including, but not limited to, identifying new technologies, research, demonstration projects, and funding opportunities; developing state, national, and international partnerships and technology transfer opportunities; and identifying and assessing research and advanced technology investment and incentive opportunities that will assist in the reduction of greenhouse gas emissions;

WHEREAS, section 38591(d) of the Health and Safety Code further provides that the Economic and Technology Advancement Advisory Committee may also advise the Board on state, regional, national, and international economic and technological development related to greenhouse gas emissions;

WHEREAS, the Board has received numerous nominations for membership on the Economic and Technology Advancement Advisory Committee and finds that proposed nominees listed below provide a broad range of relevant expertise;

WHEREAS, ARB staff has solicited nominations for the Environmental Justice Advisory Committee from environmental justice organizations and community groups, including posting a formal solicitation on the Board's Climate Change website;

WHEREAS, the Board finds that the proposed members of the Environmental Justice Advisory Committee listed below were all nominated by environmental justice organizations and community groups; and

WHEREAS, the Board further finds that the proposed members of the Environmental Justice Advisory Committee are representatives from communities in the State with the most significant exposure to air pollution, including, but not limited to, communities with minority populations or low-income populations.

NOW, THEREFORE, BE IT RESOLVED that the Board hereby forms an Environmental Justice Advisory Committee and appoints the following individuals to serve on the Committee:
