PUBLIC HEARING TO CONSIDER ADOPTION OF A REGULATION TO LIMIT OZONE EMISSIONS FROM INDOOR AIR CLEANING DEVICES

Introduction

At its September 27, 2007 public hearing, the Air Resources Board (ARB or the Board) approved the adoption of new sections 94800, 94801, 94802, 94803, 94804, 94805, 94806, 94807, 94808, 94809, and 94810 of title 17, California Code of Regulations which establish an ozone emission concentration standard, and requirements for certification, labeling and recordkeeping for indoor air cleaning devices that are introduced into commerce in California and used in occupied spaces. On June 30, 2008, the ARB released a 15-day notice informing interested parties of additional changes being proposed to the staff's original proposal, including revisions approved by the Board at its September 27, 2007 hearing. This notice also describes the availability of several additional references that are being added to the rulemaking record, as well as minor corrections to existing references in the August 10, 2007 Staff Report: Initial Statement of Reasons for Proposed Rulemaking, Proposed Regulation to Limit Ozone Emissions from Indoor Air Cleaning Devices (ISOR, Staff Report). Comments on the first 15-day notice are due by 5 p.m. on July 16, 2008. This second 15-day notice also describes the availability of several additional references that are being added to the rulemaking record, as well as minor corrections to existing references in the August 10, 2007 Staff Report.
