Notice of Public Availability of Modified Text

PUBLIC HEARING TO CONSIDER ADOPTION OF PROPOSED AMENDMENTS TO THE CALIFORNIA CONSUMER PRODUCTS REGULATION

Public Hearing Date: September 24, 2009 Public Availability Date: January 14, 2010 Deadline for Public Comment: January 29, 2010

At its September 24, 2009, public hearing, the Air Resources Board (ARB or Board) approved amendments to the Regulation for Reducing Emissions from Consumer Products (title 17, California Code of Regulations (CCR), sections 94507-94517). The amendments set new or lower volatile organic compound (VOC) standards and limited the global warming potential in Double Phase Aerosol Air Fresheners, Multi-purpose Solvents, and Paint Thinners. The amendments also prohibited the use of chlorinated toxic compounds and set an aromatic compound limit for Multi-purpose Solvents and Paint Thinners, and revised or clarified other regulatory requirements.

At the hearing, the Board approved modifications to the regulations originally proposed in the Staff Report released on August 7, 2009. These modifications include clarifications to the definitions for "Aromatic Compound," "Industrial Maintenance Coating," "Multi-purpose Solvent," "Paint Clean-up," and "Zinc-Rich Primer." Also included was a proposal to remove the VOC content labeling requirement, modifications to the public safety labeling requirement, and clarifications to the test methods and enforcement procedures used to determine compliance with the aromatic compound limit.

At the hearing, the Board adopted Resolution 09-51, which approved sections 94507-94517, as modified. Resolution 09-51 and other regulatory documents for this rulemaking are available online at the following ARB website:

In accordance with Government Code section 11346.8, the Board directed the Executive Officer to adopt the modified amendments to title 17, CCR, sections 94507-94517, after making them available to the public for comment for a period of at least fifteen days. The Board further provided that the Executive Officer shall consider such written comments as may be submitted during this period, shall make such modifications as may be appropriate in light of the comments received, and shall present the regulations to the Board for further consideration if warranted.

Summary of Proposed Modifications

- In section 94508(a), modifications were made to clarify the definitions for "Aromatic Compound," "Industrial Maintenance Coating," "Multi-purpose Solvent," "Paint Clean-up," and "Zinc-Rich Primer." For clarity, the definition of "Paint Clean-Up" was also moved into the definition of "Multi-purpose Solvent," and other definitions were renumbered to accommodate this change.
- 2. In section 94512(e), modifications were made to remove the VOC content labeling requirement staff originally proposed for Multi-purpose Solvents and Paint Thinners, to specify two additional warning display options and a font size, and to add language to the labeling requirement for flammable or extremely flammable Multi-purpose Solvents and Paint Thinners;
- 3. In section 94515, modifications were made to remove duplicative provisions and clarify what constitutes a violation of the aromatic compound limit;
- 4. In addition to the modifications described above, various modifications to the regulatory text have been made to improve clarity.

By this notice, the modified regulatory language is being made available for public comment prior to final action by the Board's Executive Officer. Attached to this notice is the text of the modified regulatory language. The originally proposed amendments are shown in <u>underline</u> to indicate additions and <u>strikeout</u> to show deletions. Modifications to the originally proposed amendments are shown in <u>double underline</u> to indicate additions and double strikeout to show deletions.
