### Notice of Public Availability of Modified Text and Availability of Additional Document

# PUBLIC HEARING TO CONSIDER PROPOSED AMENDMENTS TO THE TABLES OF MAXIMUM INCREMENTAL REACTIVITY VALUES

Public Hearing Date: November 3, 2009 Public Availability Date: February 23, 2010 Deadline for Public Comment: March 10, 2010

At a November 3, 2009, public hearing, Bart Croes, Chief of the Research Division, acting on behalf of ARB Executive Officer, James N. Goldstene, considered proposed amendments to the California Code of Regulations, title 17, sections 94700 and 94701, which consist of Tables of Maximum Incremental Reactivity (MIR) values for volatile organic compounds (VOC) and mixtures of VOC. At the hearing, ARB staff proposed additional modifications to the originally proposed amendments in the Staff Report released on September 18, 2009. These modifications would lower the number of new compounds or mixtures listed in section 94700 from "about 380" (as stated in the Staff Report) to "about 360".

The attachment to this notice shows the proposed 15-day modifications to the originally proposed regulatory language. Appendix A shows <u>underline</u> to indicate the originally proposed additions to the regulation. (There were no originally proposed deletions.) The proposed modifications are shown in <u>bold double underline</u> to indicate additions to the original proposal and <del>double strikeout</del> to indicate deletions. ### Summary of Proposed Modifications

- 1. In the original proposal, staff inadvertently proposed to add two "LEV" mixtures and six "TLEV exhaust" mixtures. Staff proposes to delete these mixtures, in order to avoid the assumption that they are regulated pursuant to section 94700.
- In the original proposal, staff inadvertently proposed to add fourteen mixtures, such as "mineral spirits". These mixtures are better represented by the 24 "bins" of hydrocarbon solvents included in section 94701 (both current and proposed versions). Staff proposes to delete these mixtures from section 94700, in order to clarify that they are regulated pursuant to section 94701.

- 3. As a result of new research, staff became aware of errors in the calculation of the MIR values for most of the substances listed in section 94700 and all the hydrocarbon bins listed in section 94701 (see supporting document below), and proposes to modify their values accordingly. The recalculated MIR values changed (mostly increased) by up to about 10% for most substances, and from zero to small positive values for some amines. As a result, staff proposes to replace the entire "New MIR Value" column in the attachment, even though MIR values for some substances did not change.
- 4. Staff proposes to add synonyms to several of the names included in the listing of compounds, in order to help readers locate compounds of interest.

#### **Supporting Document and Information**

In accordance with Government Code section 11347.1, staff has added the following document to the rulemaking record in support of the proposed action: "Updated Maximum Incremental Reactivity Scale and Hydrocarbon Bin Reactivities for Regulatory Applications," by Dr. William P. L. Carter, as revised January 28, 2010. This document is being relied on as support for the proposed modification #3 as described in this notice.

#### **Comments and Subsequent Action**

In accordance with the Government Code section 11346.8, the proposed modifications identified in Attachment A are being made available for a supplemental 15-day comment period. The Executive Officer shall consider such written comments as may be submitted during this period, and shall make such modifications as may be appropriate in light of the comments received.
