AREA DESIGNATIONS FOR STATE AMBIENT AIR QUALITY STANDARDS

Amend sections 60201 and 60210, title 17, California Code of Regulations, to read as follows:

Chapter 1. Air Resources Board
Subchapter 1.5. Air Basins and Air Quality Standards
