

## **APPENDIX B. WESTERN CLIMATE INITIATIVE DEVELOPMENT AND STAKEHOLDER PROCESS**

### **A. Introduction**

Climate change is a global problem. California is working with other U.S. states and Canadian provinces to develop and encourage wider action. One cooperative effort is the Western Climate Initiative (WCI), described in more detail below.

The WCI is a collaboration of independent jurisdictions working together to identify, evaluate, and implement emissions trading policies to tackle climate change at a regional level. This is a comprehensive effort to reduce greenhouse gas (GHG) pollution, spur investment in clean-energy technologies that create green jobs, and reduce dependence on imported oil. Its Partner jurisdictions currently include California, Québec, British Columbia, Manitoba, and Ontario.

A regional emissions-reduction program would have several advantages for California. Broader participation leads to greater emissions reductions. Reductions from a regional program of all five WCI partners would be nearly double those that California could achieve on its own. A regional program would provide greater flexibility to California businesses by offering a wider range of emissions reduction opportunities and greater market liquidity, lowering overall costs. It would also pave the way for additional states and provinces, and federal governments, to implement linked or similar programs.

California has worked with its WCI partners since 2007 to unlock the benefits of a regional program by coordinating on cap-and-trade program design. The California program could stand on its own, or be linked to those of its partners through mutual recognition of jurisdictions' compliance instruments. Throughout this coordination process, California and the WCI have sought stakeholder input.

The Air Resources Board and California Environmental Protection Agency have hosted eleven workshops primarily on the WCI and linking, in addition to discussions of WCI design issues at multiple other workshops (CARB 2010).

A complete list of WCI stakeholder consultations is in Section D. To date, the WCI has had 138 separate engagements with stakeholders, including 138 documents; 86 stakeholder meetings, webinars, and calls; and has received written comments on 48 occasions. Some engagements included all three of these elements, while some included only one.

The following sections of this Appendix are a short history of the Western Climate Initiative; a summary of California-hosted stakeholder engagement on the WCI; the text of the documents and presentations used to solicit WCI stakeholder comment; and the text of the documents and presentations used to solicit

California stakeholder comment on WCI issues. The groups of WCI stakeholders and California stakeholders significantly overlap.

## **B. A Short History of the Western Climate Initiative**

The WCI began in February 2007 with an agreement (WCI 2007a) between the governors of Arizona, California, New Mexico, Oregon, and Washington to set an overall regional goal to reduce emissions consistent with state-by-state goals; develop a design for a regional market-based multi-sector mechanism to achieve the regional GHG-reduction goal; and participate in a multi-state GHG registry to enable tracking, management, and crediting for entities that reduce GHG emissions.

In August 2007, the Partners published the regional goal (WCI 2007b), based on individual jurisdictions' goals. In September 2008 the WCI published its cap-and-trade design recommendations (WCI 2008a). All the jurisdictions joined The Carbon Registry.

In October 2007, the WCI published a 2007–2008 work plan (WCI 2007c). In January 2008 subcommittees of the WCI published options papers on aspects of cap-and-trade design (WCI 2008a – WCI 2008e), and held an in-person meeting with stakeholders and invited written comments. The subcommittees published draft design recommendations in March 2008 (WCI 2008f – WCI 2008j), and the WCI published consolidated draft recommendations in May 2008 (WCI 2008k). In July 2008 the WCI published a draft design (WCI 2008l), along with draft recommendations on the essential elements of a greenhouse gas reporting program (WCI 2008m). They held a second in-person meeting with stakeholders. The landmark Design Recommendations for the WCI Regional Cap-and-Trade Program were published in September 2008 (WCI 2008n), as was a second draft of the reporting elements (WCI 2008o).

Throughout 2008, the WCI kept stakeholders apprised of its economic modeling efforts, and the Design Recommendations included detailed results and analysis. In late 2008 and early 2009 the WCI held technical workshops on its economic modeling and on treatment of the electricity sector. It also published a third draft of reporting elements.

The 2009–2010 work plan (WCI 2009), published in January 2009, described tasks for six committees and an economic modeling team. The six committees were: Reporting, Cap Setting and Allowance Distribution, Markets, Electricity, Offsets, and Complementary Policies. Each of the committee tasks included stakeholder outreach, such as white papers and draft and final recommendations. The committees also hosted public webinars to receive information and advice from outside experts. Monthly stakeholder newsletters and bimonthly calls provided additional information and opportunity to comment. Final essential requirements for mandatory reporting were published in July 2009. July 2010 saw the culmination of this work period, with the issuance of an

updated economic analysis (WCI 2010a) and the design for the WCI Regional Program. The design included a narrative summary and a detailed design in regulatory-style language (WCI 2010b).

Since that time, the jurisdictions have been active in harmonizing the reporting elements with U.S. and Canadian federal government requirements to minimize the effort for reporting entities. The WCI has also moved toward implementation with recommendations on the processes to establish offset protocols and issue offset credits. The WCI continues to work on implementation as various jurisdictions enact and prepare their programs.

**C. Summary of California Stakeholder Engagement on the WCI**

In addition to the numerous opportunities to comment on the WCI process and recommendations, California hosted eleven public workshops specifically on California’s engagement. Eight of these were titled “Climate Initiative Dialogue Group,” and co-hosted by the Air Resources Board and the California Environmental Protection Agency. Three were hosted by ARB. These are listed in Table I-2. The ARB stakeholder process on the Cap-and-Trade Regulation also included numerous workshops at which participation in the WCI and elements of the WCI design recommendations were discussed; see Cap-and-Trade ISOR Appendix D (CARB 2010).

**D. Stakeholder Engagement Documents and Presentations**

This section is a compendium of the documents and presentations used to inform stakeholders of WCI progress and invite comment. In Table I-1, documents released by the WCI are followed by documents released by California agencies. Within those sections, the compendium is organized by date of the document release or stakeholder event. In several cases, multiple documents were released on the same day, often as part of the same engagement opportunity.
