In February 2020, California Air Resources Board (CARB) staff began informing the public of the proposed Advanced Clean Fleets (ACF) regulation and development process. As of June 2022, staff have conducted or directly participated in more than 386 meetings and events with over 170 stakeholders. Most of these meetings were held remotely due to the Coronavirus pandemic.

Staff offered engagement opportunities to solicit for alternatives and receive feedback from a variety of interested parties and stakeholders including manufacturers, large fleet owners, single truck owner-operators, environmental advocacy organizations, and the communities impacted most heavily by medium- and heavy-duty vehicle emissions.

Staff met and continue to meet with stakeholders individually and in groups to discuss a range of rulemaking topics including high priority and public fleets, drayage, delivery, manufacturing, vehicle availability, exemptions, implementation, infrastructure, and many others.

Table 1 contains a list of meeting and events related to the proposed ACF regulation with number, date, primary meeting attendees, and main topic discussed.
