## Notice of Public Meeting to Consider the Proposed South Coast Air Basin Attainment Plan for the 2012 Annual PM2.5 Standard

The California Air Resources Board (CARB or Board) will conduct a public meeting at the date and time noted below to consider the adoption of the South Coast Air Basin Attainment Plan for the 2012 Annual PM2.5 Standard (2024 South Coast PM2.5 Plan) developed by the South Coast Air Quality Management District (District). If adopted, CARB will submit the 2024 South Coast PM2.5 Plan and CARB Staff Report to the U.S. Environmental Protection Agency for inclusion in the California State Implementation Plan.

#### Background

The Clean Air Act establishes planning requirements for areas that exceed the healthbased national ambient air quality standards. States with areas that exceed any standards must develop and implement a State Implementation Plan that demonstrates attainment of those standards by a specified date and that meets other Clean Air Act requirements.

The South Coast Air Basin is designated as nonattainment for the 12  $\mu$ g/m3 annual PM2.5 standard established in 2012. In 2017, CARB submitted to U.S. Environmental Protection Agency the 2016 Air Quality Management Plan which addressed moderate and serious nonattainment area Clean Air Act requirements for the South Coast Air Basin for the 12  $\mu$ g/m3 annual PM2.5 standard, and demonstrated attainment by the

December 31, 2025, serious area deadline. The U.S. Environmental Protection Agency approved the moderate area State Implementation Plan elements and established due dates for the serious requirements, including a December 31, 2023, due date for the attainment demonstration. Unfortunately, due to multiple factors including increased emissions from the sources at the ports beginning during the pandemic, unexpected weather patterns that promote the formation of PM2.5, and the installation of new, near-roadway monitors, attainment by December 31, 2025, is now less certain. Since the U.S. Environmental Protection Agency had not acted on the serious area elements and they were submitted early, CARB and the District withdrew from inclusion in the California State Implementation Plan the serious area elements that were submitted as a part of the 2016 Air Quality Management Plan.

Many air pollution problems are interrelated and require multifaceted approaches to solve them. Relevant here, to support attainment of a different national ambient air quality standard, the 70 ppb 8-hour ozone standard, CARB developed the *2022 State Strategy for the State Implementation Plan,* which was adopted by the Board in September 2022. The 2022 State SIP Strategy described the control measures from State-regulated sources that CARB will pursue to reduce emissions to the levels needed for attainment of that ozone standard across California. Many of the measures committed to in the 2022 State SIP Strategy provide air pollutant reductions over the next 5 years that also support attainment of the 12  $\mu$ g/m3 annual PM2.5 standard in the South Coast Air Basin.

In addition, to meet serious nonattainment area requirements and demonstrate attainment using the latest air quality data, the District developed the 2024 South Coast PM2.5 Plan. This plan incorporates emission reductions from measure commitments in the 2022 State SIP Strategy, and reductions from District measures, to demonstrate attainment of the 12  $\mu$ g/m3 annual PM2.5 standard by December 31, 2030. Alongside the 2024 South Coast PM2.5 Plan, the CARB Staff Report contains the State's proposed commitment to achieve aggregate emissions reductions of 9.1 tons per day of oxides of nitrogen, 0.2 tons per day of ammonia, and 0.5 tons per day of direct PM2.5 reductions in the South Coast in 2030.

The 2024 South Coast PM2.5 Plan demonstrates attainment of the 12  $\mu$ g/m3 annual PM2.5 standard by the December 31, 2030, extended deadline and addresses all other requirements of the Clean Air Act for a serious nonattainment area for the 12  $\mu$ g/m3 annual PM2.5 standard. The requirements include emission inventories, a Best Available Control Measure/Best Available Control Technology demonstration, a Most Stringent Measure demonstration, a reasonable further progress demonstration, quantitative milestones, and contingency measures. As detailed in the CARB Staff Report, CARB staff has reviewed the 2024 South Coast PM2.5 Plan and has concluded that it meets the requirements of the Clean Air Act for the 12  $\mu$ g/m3 annual PM2.5 standard. The CARB Staff Report also includes updated motor vehicle emission budgets consistent with the reasonable further progress and attainment demonstrations.

#### **Proposed Action**

CARB staff recommends that the Board adopt the State commitment to achieve specified emissions reductions by 2030 and the motor vehicle emissions budgets as included in the CARB Staff Report; adopt the 2024 South Coast PM2.5 Plan; and direct staff to submit the relevant portions of the 2024 South Coast PM2.5 Plan along with the CARB Staff Report to the U.S. Environmental Protection Agency as a revision to the California State Implementation Plan. CARB staff will present a written report at the meeting.
