The California Air Resources Board (CARB or Board) will conduct a public meeting at the date and time noted below to hear an informational update on progress to implement the Community Air Protection Program (CAPP or Program).

This public meeting may continue at 9:00 a.m., on July 24, 2026. Background

The Board will hear an informational update on progress to implement the [Community Air Protection Program](#) (CAPP or Program), including related updates on newly adopted or approved community emissions reduction programs, monitoring, enforcement, community air grants activities and on-going efforts to support consistently nominated communities.

California's air quality programs continue to significantly improve public health statewide through various measures such as regional air quality planning, advancements in technology-based solutions, and risk reduction efforts near industrial facilities. However, despite these efforts, certain communities, particularly low-income and communities of color, still experience environmental and health inequities from air and other forms of pollution. [AB 617](#) (C. Garcia, Stats. 2017, Ch. 136) was signed into law in July 2017. AB 617 requires new community-focused action to reduce health-harming emissions of toxic air contaminants and criteria air pollutants in communities affected by a high cumulative exposure burden.

CAPP Annual Progress Update

The staff presentation will highlight the Program's progress over the past year, including commitments outlined in [Blueprint 2.0](#). The update will cover the status of Community

Emission Reduction Program (CERP) communities, key actions taken to implement CERPs, progress on Community Air Protection (CAP) Incentives, and collaborative efforts with community members, air districts, and CARB. It will also provide updates on air quality monitoring, efforts to support *consistently nominated communities* through grants and other funding, and commitments for the upcoming year.

This year, the Board will hear directly from Air Pollution Control Officers, Air District board members, and Community Steering Committee (CSC) members about CERP implementation progress within their communities. This will include updates from communities nearing completion of their CERP commitments as well as those with a newly adopted CERP. Invited speakers will share their experiences, lessons learned, and strategies for addressing remaining implementation challenges, and will discuss how communities across the state can benefit from these insights. The Board may also hear from advocates from *consistently nominated communities* that are using grant monies to support communities in different parts of the State.

The Community Air Protection Program Annual Progress Report delivers a comprehensive update on the Program's yearly advancements in a refreshed format. The accompanying StoryMaps have been revamped to include a comprehensive website experience showcasing first-hand community perspectives and direct narratives from participants' experiences.
