In accordance with our telephone conversation today, I enclose a corrected original and five copies of the Final Regulation Order, to be substituted in the rulemaking file for the above rulemaking. The substitute Final Regulation Order reflects the following corrections:

- (1) In the footer throughout the document, "As Submitted: September 23, 2003" is changed to "As corrected November 3, 2003".
- (2) On page 1, after the title of section 1956.1, title 13, California Code of Regulations, "(a) [No change.]" is changed to "(a) and (b) [No change.]"
- (3) On page 1, in the last three lines of section 1956.1(c), "California Interim Certification Procedures for 2004 and Subsequent Model Hybrid-Electric Vehicles Classes," adopted October 24, 2002, . . ." is changed to "California Interim Certification Procedures for 2004 and Subsequent Model Hybrid-Electric Vehicles, in the Urban Bus and Heavy-Duty Vehicle Classes," adopted October 24, 2002, . . ."

- (5) On page 4, subsection (d), the indentation of the first line is reduced, and “California Interim Certification Procedures for 2004 and Subsequent Model Hybrid-Electric Vehicles Classes,” adopted October 24, 2002, . . .” is changed to “California Interim Certification Procedures for 2004 and Subsequent Model Hybrid-Electric Vehicles, in the Urban Bus and Heavy-Duty Vehicle Classes,” adopted October 24, 2002, . . .”
- (6) On page 4, first line of Authority Note, “43100” is inserted; in Reference Note, third line, “43101.5” is deleted.
- (7) On page 6, in the last line of section 1961(a)(8)(B), “section 1962(h).” is changed to “section 1962.”
- (8) On page 7, after the title of section 1961(b), the underlining is removed from “Subsections (b)(1) through (b)(2). [No change.]” and that text is aligned with the right margin.
- (9) On page 9, at the end of the regulatory text, the underlining of ““ZEV” means zero-emission vehicle.” is removed.
- (10) On page 11, in the sixth line of section 1978(b), “21001” is changed to “2001”.
