The Air Resources Board (ARB or Board) will conduct a public meeting at the time and place noted below to consider action to accept or reject the Council of Fresno County Governments' (FCOG) determination that its 2014 Sustainable Communities Strategy (SCS), if implemented, would achieve the region's per capita greenhouse gas (GHG) emissions reduction targets for 2020 and 2035. Staff will present its technical evaluation of FCOG's greenhouse gas determination for the 2014 SCS which was adopted by FCOG on June 26, 2014.

This item will be considered at a one-day meeting of the Board, which will commence at 9:00 a.m., January 29, 2015. Please consult the agenda for the meeting, which will be available at least 10 days before January 29, 2015, to determine the order in which this item will be considered.

Each of California's Metropolitan Planning Organizations (MPO) must prepare an SCS as an integral part of its Regional Transportation Plan (RTP). The SCS contains land use, housing, and transportation strategies that, if implemented, would allow the region to meet the per capita GHG emission reduction targets established for the region by the Board. Once adopted by the MPO, the SCS guides the transportation policies and investments for the region. The Board must either accept or reject FCOG's determination that its RTP/SCS submitted to ARB would, if implemented, meet the GHG reduction targets of 5 percent by 2020 and 10 percent by 2035, from a base year of 2005. Staff will present the results of its evaluation of FCOG's GHG determination, which is based on a review of the technical methodology that FCOG used to quantify its GHG emission reductions.
