NOTICE OF PUBLIC MEETING TO CONSIDER AN UPDATE TO THE SAN JOAQUIN VALLEY PM10 MAINTENANCE PLAN

The Air Resources Board (ARB or Board) will conduct a public meeting at the time and place noted below to consider the adoption of an update to the San Joaquin Valley Air Pollution Control District (District) PM10 Maintenance Plan (Update). If the update is adopted, ARB will submit the plan update to the United States Environmental Protection Agency (U.S. EPA) as a revision to the California State Implementation Plan (SIP).

This item will be considered at a one-day meeting of the Board, which will commence at 9:00 a.m., April 27, 2017. This item is scheduled to be heard on the Board's Consent Calendar. All agenda items on the Consent Calendar – unless removed upon the request of a Board member or if someone in the audience submits a request to speak card on that item – will be voted on by the Board at the beginning of the public meeting.

Background

In 2008, U.S. EPA approved the San Joaquin Valley 2007 Maintenance Plan (Maintenance Plan) and designated the San Joaquin Valley as attainment for the federal 24-hour PM10 standard of 150 $\mu g/m^3$. The Plan outlined contingency provisions the District will take should exceedances of the PM10 standard occur. These provisions require an assessment of the nature of the exceedances and identification of potential remedies.

As part of the process to update the Maintenance Plan's transportation conformity budgets, ARB committed to provide U.S. EPA a SIP revision with documentation on the nature and causes of the PM10 exceedances that occurred in the Valley in 2013 and 2014 to fulfill the contingency requirement of the Maintenance Plan. In the Update, ARB staff has assessed available information for each exceedance and identified whether the exceedance may qualify as a natural or exceptional event or was caused by anthropogenic sources. Based on this identification, the assessment also identifies the actions underway to ensure continued maintenance of the PM10 standard.

Proposed Action

ARB staff recommends that the Board adopt this Update to the San Joaquin Valley PM10 Maintenance Plan and direct staff to submit it to U.S. EPA as a revision to the California SIP.
