

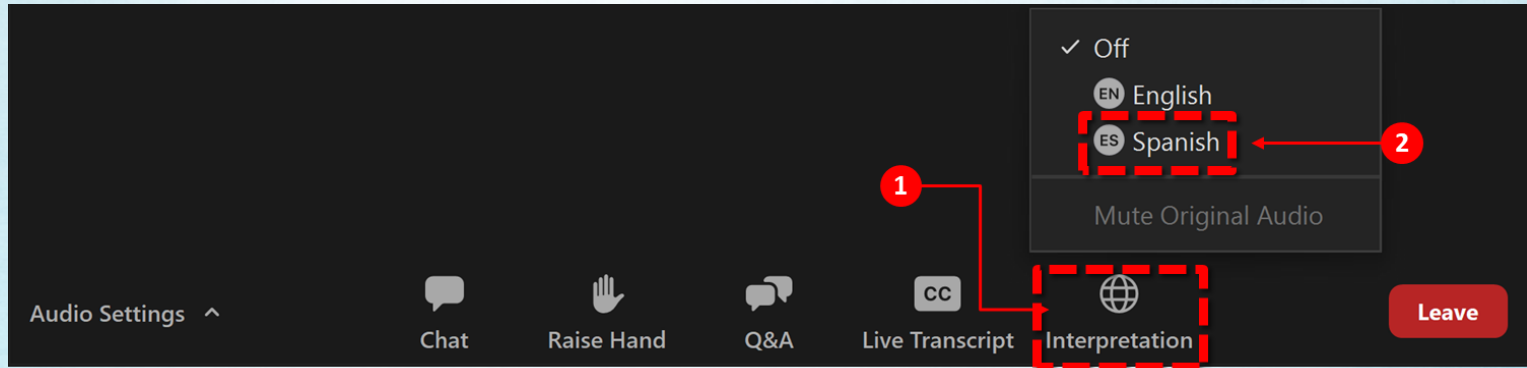

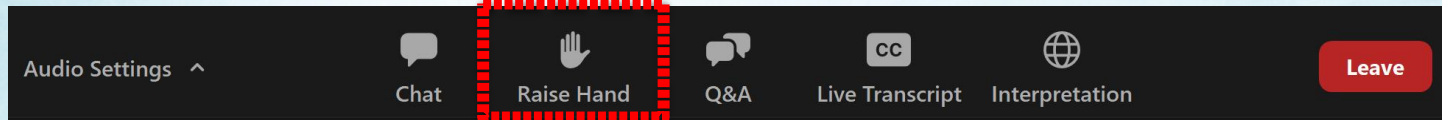

- Apply to new engines
- Certification required prior to sale
- No in-use requirements for equipment owners
- Owners may continue purchasing and using equipment



Update on Landscaping Equipment Rules

- US EPA authorized amended rules
- Full implementation beginning 2026
- Manufacturers may certify 2025 engines
- Dealers may continue selling landscaping equipment

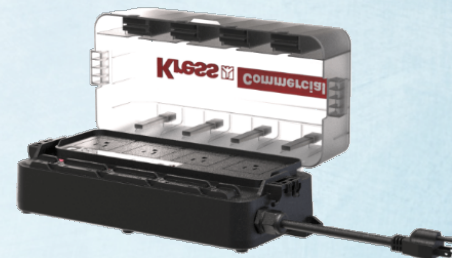
