# 2021 Data Reporting Recap

- 832 reports submitted
- 493 verified
  - 100% received positive / qualified positive emissions verification statements
- Other reports not subject to verification (i.e., abbreviated reporters or retail providers with no imports/exports)

# Key Reporting Dates for 2022 Data

### https://ww2.arb.ca.gov/mrr-key-dates

Date	Activity
April 10	Regulatory Deadline: Reports due for facilities and suppliers of fuels and carbon dioxide, except when subject to abbreviated reporting
June 1	Regulatory Deadline: Reports due for electric power entities and those subject to abbreviated reporting
August 10	Regulatory Deadline: Verification statements due (emissions data and product data)

# Reporting and Verification Schedule

- RY2022 is the second year of the compliance period
  - Site visits optional unless you hire a new verifier or had a qualified positive verification statement last year
- Verification statements due by Aug. 10<sup>th</sup>, 2023
- No extensions to reporting or verification deadlines
- Failure to submit a report or verification by the required deadline is a violation of the regulation for each day the report or verification is late

## Enforcement

- Issues that could lead to enforcement
  - Incorrect data reported
  - Failure to fix correctable errors that result in an adverse statement
  - Late reports or failure to report
  - Late verification or failure to verify
- CARB has completed enforcement actions related to reporting

- If you think you may be eligible for cessation of reporting or verification [pursuant to section 95101(h)] or are ceasing operations [section 95101(i)], contact CARB staff before the reporting deadline so we can ensure regulatory requirements are appropriately met
- Contact CARB for any questions about requirements (<u>ghgreport@arb.ca.gov</u>)
  - Save and file any CARB responses as part of your GHG Monitoring Plan and provide to your verifier

### Verification Essentials

- New verification body is required every six years
- Be prepared to trace data to its origin
- Ensure GHG Monitoring Plan meets the requirements of section 95105(c) and includes any additional information that would be helpful to your verifier
- Correctable errors must be fixed. If not, verifier must submit an adverse statement
- If verifier or reporter is unsure of requirements, please contact CARB for assistance
  - Retain written/emailed guidance from CARB staff for review by your verifier

### Verification Best Practices

- Initiate verification as soon as possible to allow time for revisions
- Streamline verification:
  - Execute verifier contract prior to report certification
  - Associate your report with your verifier at any time
  - Provide data to verifiers ASAP
  - It is good practice to have a webinar prior to a site visit (if required)
    - Be ready for questions early in the process from your verifier
    - If no site visit is conducted, we highly recommend a webinar with screenshare
  - Communicate promptly to ensure important issues are discussed early
- Start early and plan to finish early to ensure timely submittal

# **Reporting Reminders**

- Don't forget to submit and certify a generated report
- If your report won't generate:
  - Clear all validation messages
  - Clear a pending Certificate of Representation (COR)
  - Time-out issues: Try generating your report 3-4 times, then notify CARB
- As the DR (Designated Representative), notify CARB if you will no longer serve as the DR
  - It's the company's responsibility to notify CARB and re-assign someone as the DR
  - We've had issues tracking down new personnel when the DR leaves, therefore, we <u>highly</u> recommend all reporters designate an ADR (Alternate Designated Representative)
  - Late reporting violations do apply in such cases
- Notify CARB promptly if your facility is being sold or operational control is switching to a different operator
  - CARB will evaluate responsibility for reporting, verification, and C&T compliance
  - Can be complicated if transfer occurs during verification

# **Clearing Validation Messages**

Example: For electricity generating facilities, total facility electricity generation, and nameplate capacity in Subpart A must equal the sum of unit-level electricity generation and nameplate capacity in Subpart C

# Clearing a Pending COR

- When a new DR/ADR accepts their invitation, a Certificate of Representation (COR) must be signed
- An incomplete COR appears under Home tab of invitee's account
- Report cannot be certified and submitted with a pending COR



### CARB Quality Assurance (QA)

Process:

- CARB staff complete QA checks on reported data
- Send outreach to reporters and/or verifiers if potential errors are identified via direct email, phone call, or finding reports
  - 1. Spring/Summer Outreach = Reactive. To correct errors made in current reporting year data prior to verification deadline
  - 2. January Outreach = Proactive. To prevent errors identified in prior reporting year from occurring in the new reporting year

### CARB QA Outreach: Findings Reports

- What are they? Excel csv file that lists QA check findings applicable for a particular reporting entity ("entity report") or for a particular user ("user report")
- When are they issued?
  - January: When Cal e-GGRT goes live (for proactive QA)
  - Late May: For reactive QA
- Where do I find them?
  - Entity report is uploaded into the <u>Cal e-GGRT entity account</u> for the relevant RY (Under Data Reporting > Select Facility > Facility or Supplier Overview: CARB ATTACHMENTS
  - User report is uploaded into the <u>Cal e-GGRT user account</u>. (Under My Profile > Exchange Files with CARB: DOWNLOAD FILES FROM CARB)
- How do I know when a finding report has been issued? After reports have been uploaded in Cal e-GGRT, CARB will notify reporters and verifiers associated with entities who have been issued reports

- Entity report is uploaded into the <u>Cal e-GGRT entity account</u>
- User report is uploaded into the <u>Cal e-GGRT user account</u>


# Units Reporting Thermal Energy

- Thermal energy disposition in Subpart A needs to match closely with total thermal output in Subpart C
- Keep in mind: total thermal output should roughly equal how much steam you use + how much steam you sell

# Cogen/Bigen Units

- Total thermal output + total electricity generation should not exceed total unit heat (fuel) input(s)
- Important to double check because CARB is estimating emissions from electricity generation



## Guidance for Suppliers of Biofuels

- The MRR point of regulation (POR) for transportation fuel suppliers [§95121)(a)(2)] specifies that only enterers who import and supply <u>fossil</u> fuels outside of the bulk/terminal system are subject to reporting emissions from imported fuels. Entities who import only biofuels do not need to report emissions from imported fuels.
  - Ex. A supplier imports only R80/B20 (80% renewable diesel, 20% biodiesel) and supplies it outside of the bulk system = Entity is not required to report any emissions from imported biofuels
- COI fee requirements [95121(d)(7) (8)] apply to all subject transportation fuel suppliers
  - Ex. If a supplier imports only BD, but is subject to 95121 reporting because they also supply fuel across a terminal rack, they will need to report imported BD for COI fee purposes, but not emissions reporting
- Only emissions from fuels listed in Table 2-5 are reportable under section 95121

# Method Change Requests

- Section 95103(m) of MRR provides requirements for:
  - Temporary or permanent changes to prescribed methods
  - Alternative measurement and monitoring methods
- Contact CARB if a method change is needed
- Submit requests as soon as possible to facilitate approval in timely manner

- Verifiers submit conflict of interest forms via Cal e-GGRT
  - Approvals from CARB typically take less than a week
  - New reporters must select a VB before verifier can submit COI

# Greatest Risks for Mis-reporting

- New reporting entity staff
  - Please keep DR/ADR info up to date so we can contact new staff
  - If you need help, please <u>reach out!</u> That's what we're here for
- Assuming previous methods/reported data were correct
  - Contact CARB staff to confirm your own understanding of basic reporting requirements

### Cost of Implementation Fee Update

- Starting this year, CARB will send COI fee invoices electronically by upload to Cal e-GGRT (e.g., RY2021 accounts for this year), and via email attachment to DRs, ADRs, and the listed Responsible Party
- Please ensure your DR, ADR, and/or Responsible Party for Payment and Email has been updated when the invoices are posted usually in late-June/mid-July
- We will not share invoices with parties who are not explicitly affiliated with your current account in the tool even if requested by the DR or ADR, but you may forward along your emails if you choose
