Overview

2015 Data Reporting Recap

- 804 reports submitted
- 516 verified
 - 99+% received positive or qualified positive emissions verification statements
 - Other reports not subject to verification (abbreviated or retail provider with no imports/exports)
- 2015 summary data posted for all reports
 - http://www.arb.ca.gov/cc/reporting/ghg-rep/reporteddata/ghg-reports.htm

Reporting Schedule

- June 1, 2017
 - Reports due for EPEs and electricity retail providers
 - No time extensions
- Failure to submit a report by the required deadline is a violation of the regulation for each day the report is late

Verification Schedule

- Must be completed by September 1, 2017
 - No time extensions
 - Less-intensive verification this year with option for no site visit if:
 - Positive verification statement last year and did not change verification body
 - Site visit or webinar should be considered to expedite verification process, facilitate data sharing, and increase verifier confidence
- Begin verification process as soon as possible (e.g., contracting and scheduling). Do not wait until reporting is completed
- Verifiers must submit an <u>adverse</u> statement if verification not completed on time
- Failure to have a verification statement submitted by the verification deadline is a violation of the regulation for each day the verification statement is late

Enforcement Summary

- Issues that could lead to enforcement include:
 - Incorrect data submitted
 - Errors leading to a material misstatement (includes errors present at the reporting or the verification deadline)
 - Failure to fix correctable errors
 - Late reports or failure to report
 - Late verification or no verification
- ARB has completed enforcement actions related to reporting, and continues enforcement activities

Regulation Updates

- Mandatory Reporting Regulation
 - No 2016 MRR updates
 - No new provisions take effect for 2016 data

- Cap-and-Trade Regulation
 - For EPEs, no changes to Covered Emissions calculations

Cal e-GGRT Tool Availability

- Tool available NOW
 - 2016 data reporting activated
- Electric Power Entity module has been activated



Reporting Tips

- Start early, finish early
- Involve verifier as soon as possible
 - Include enough time to revise data based on verification
 - Some reporters are reaching the 6-year time limit with the same verification body and must hire a new verifier. Contact ARB if unsure.
 - New verification body = site visit required
 - Reminder: Complete and accurate data must be submitted by the reporting deadline
- Update DR, ADR, Agents as needed
 - Old employees, etc., have access to system until you remove them

 - Save and file any ARB responses as part of your GHG Inventory Program

Verification Tips for Reporters

- Correctable errors must be fixed
 - If not, verifier must submit <u>adverse</u> statement
- "Covered emissions" data must meet accuracy requirements and be reasonably assured of no material misstatement
- If verifier and reporter disagree on requirements, <u>always</u> contact ARB for assistance
- Ensure GHG inventory program meets the requirements of section 95105(d) and includes helpful information
 - Robust description of key personnel and procedures
 - Provide copy to verifier as soon as possible
- Provide all ARB written clarifications for reporting to verifier

Verification Process Timing

- Reporters can improve process by:
 - Ensuring contracting is in place and COI is submitted to ARB prior to report submission
 - Providing data to verifiers ASAP after report submission
 - Scheduling site visit, or remote desktop (webinar) review in June
- Ask questions of ARB early to ensure sufficient time to address issues
- Reporters and verifiers should work together to facilitate earlier site visits and submission of verification statements

Cal e-GGRT and Workbook Updates & Review

Preliminary Emission Factor List

- ARB provided draft specified source emission factors based on February 1 Specified Source Registration workbooks
 - Allows EPEs to ensure all of their sources are included in the workbooks and the emission factors are reasonable based on publicly available data
 - Staff found this very helpful to ensure the workbook is complete before posting and it was well received by EPEs
 - Release planned again for next year

- Removed GPE field from the Reporter Info tab
 - Field was obsolete given last year's revisions to GPE fields in the Spec Info tab in Columns AR to AU
- Exports Transmission Loss Factor always TLF = 1.0
 - In Cal e-GGRT HTML Report and in Workbook 1
- Minor field label updates, where an EF component should have been just CO₂, not CO₂e
