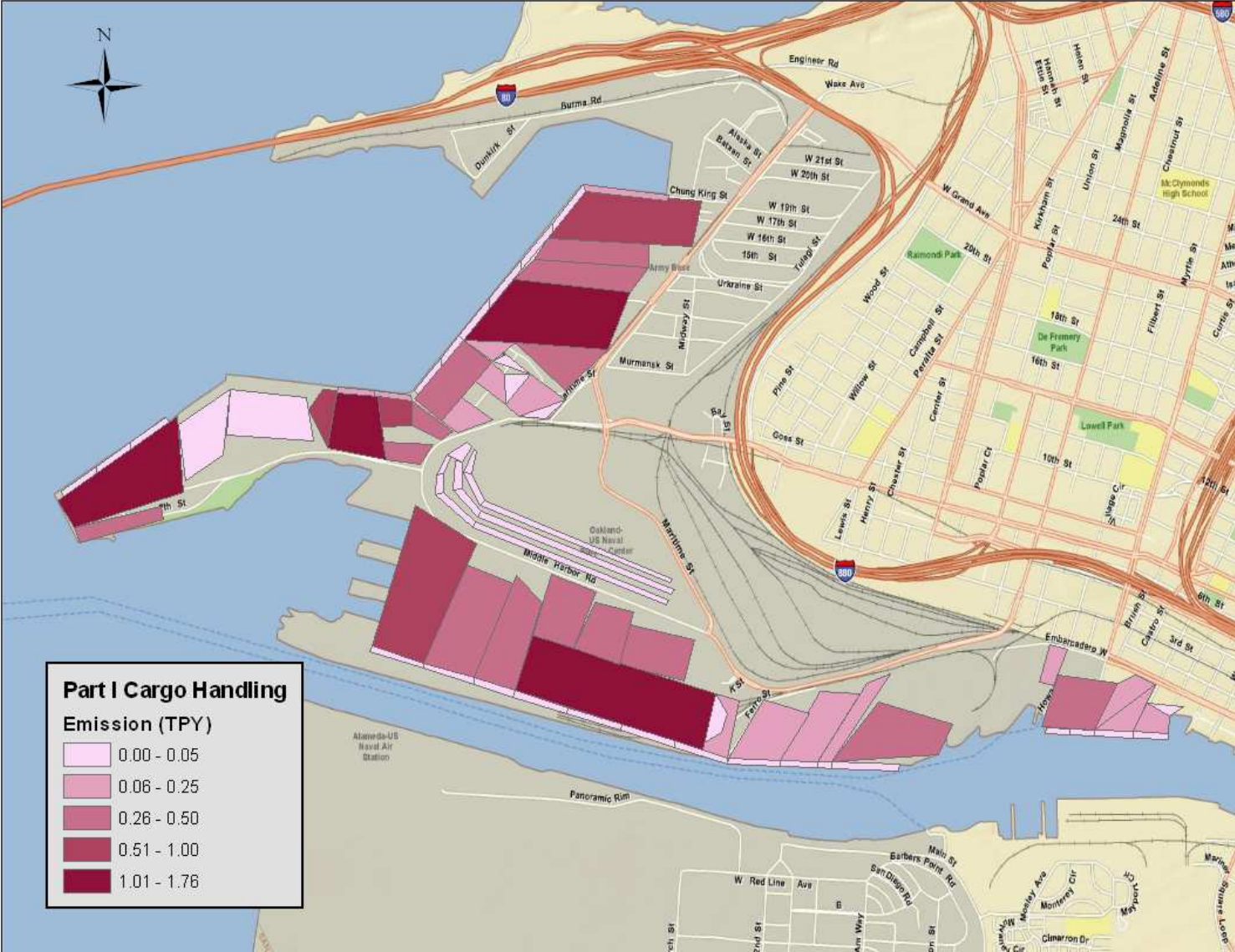

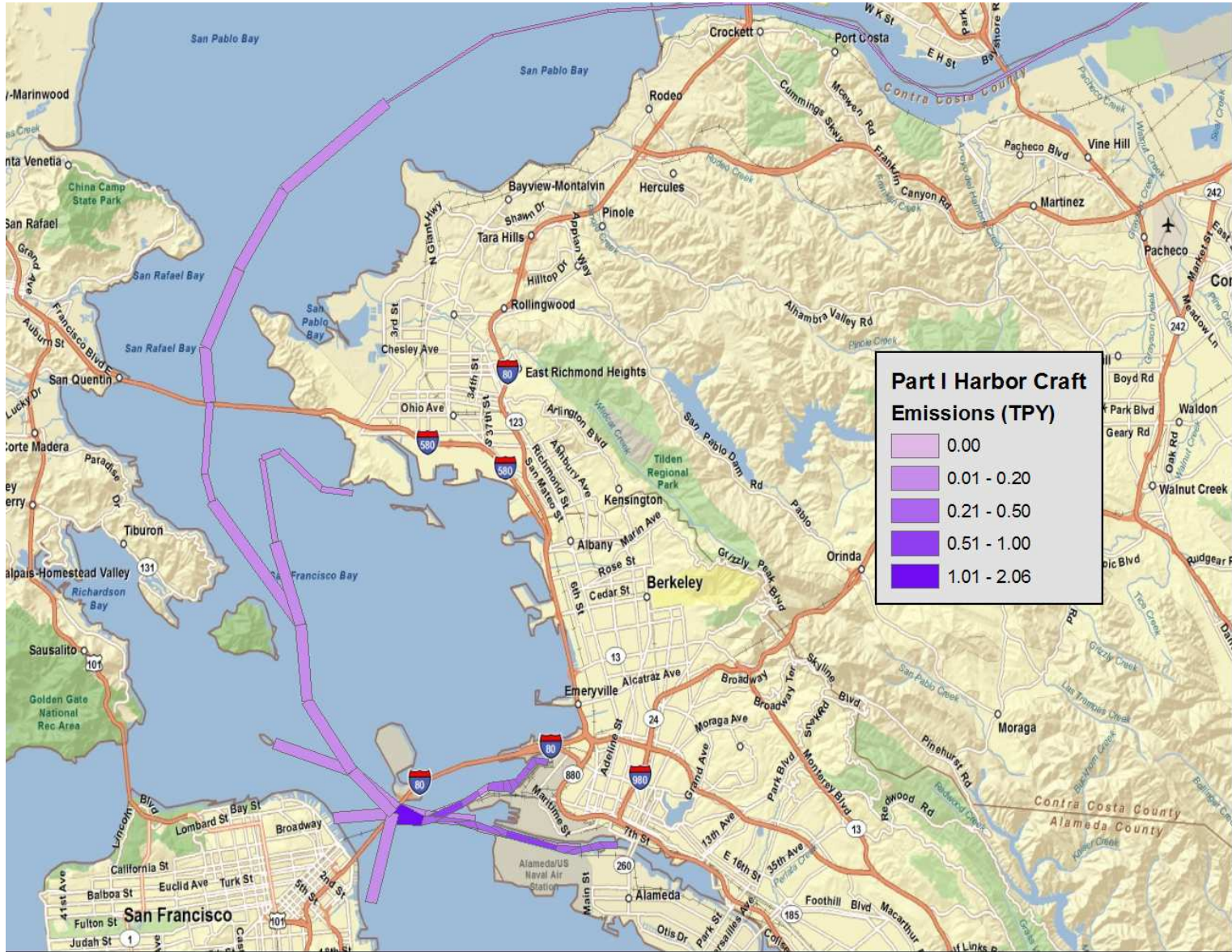

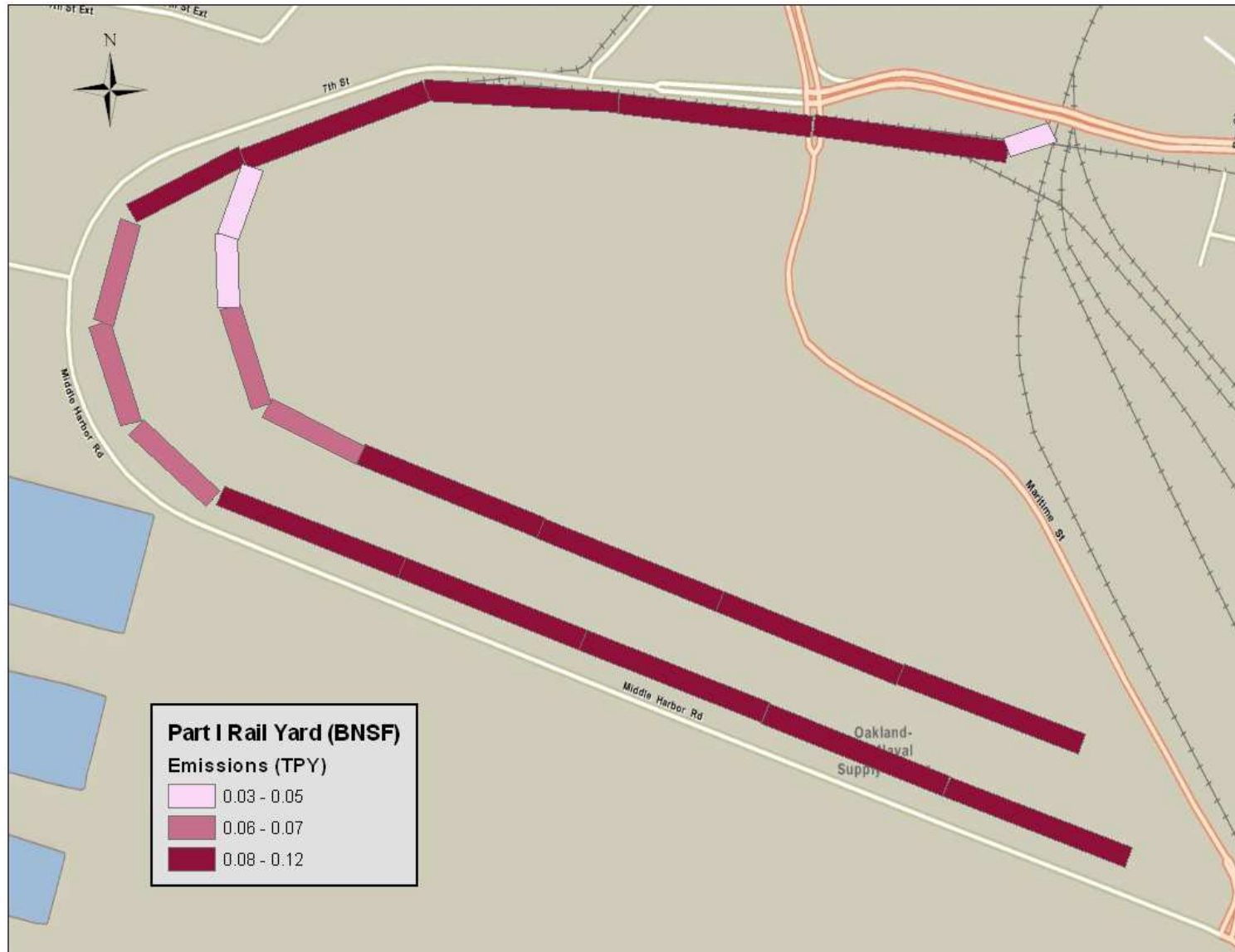
Plot E.1: Cargo Handling Emission Distribution for Part I



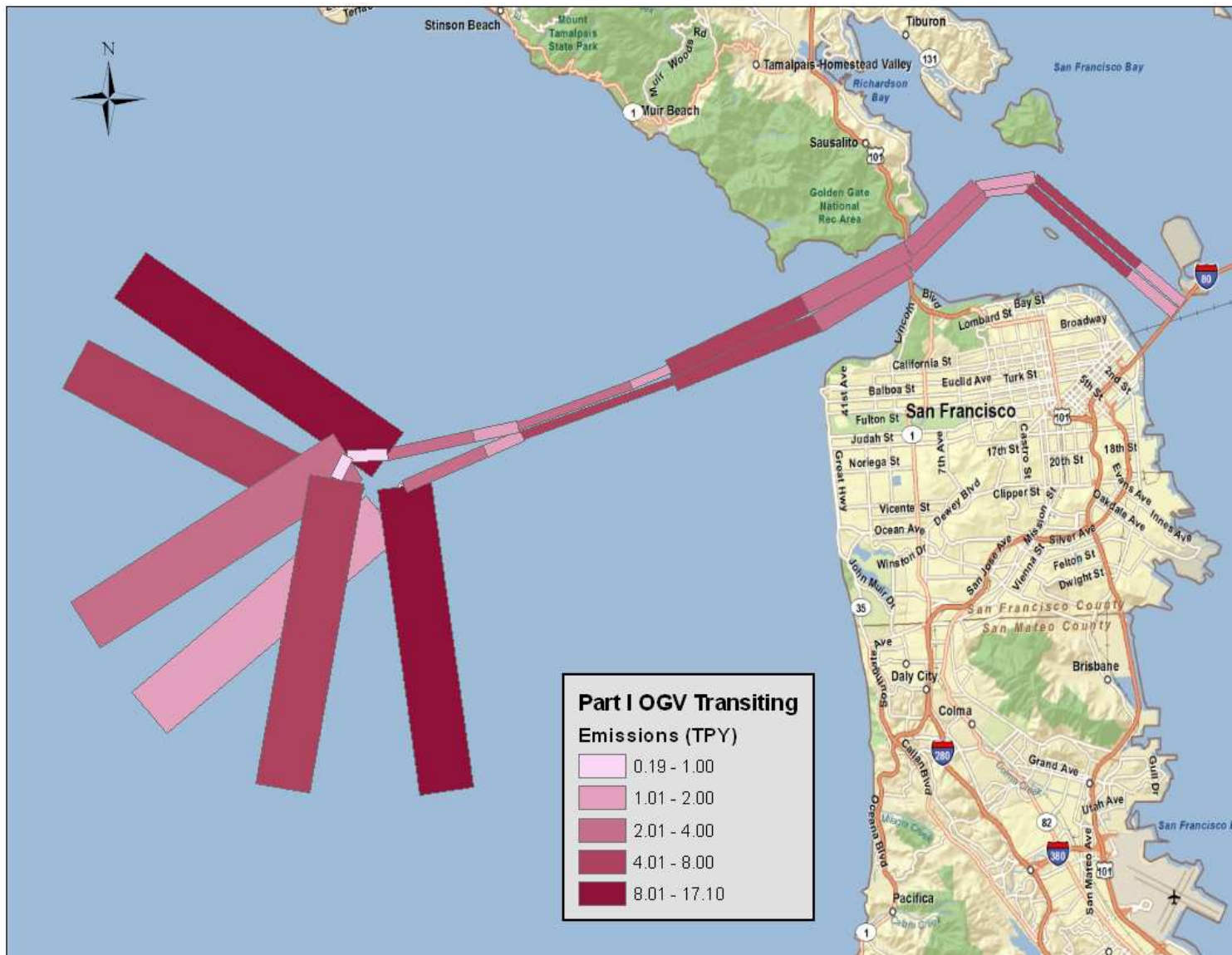
Plot E. 2: Commercial Harbor Craft Emission Distribution for Part I



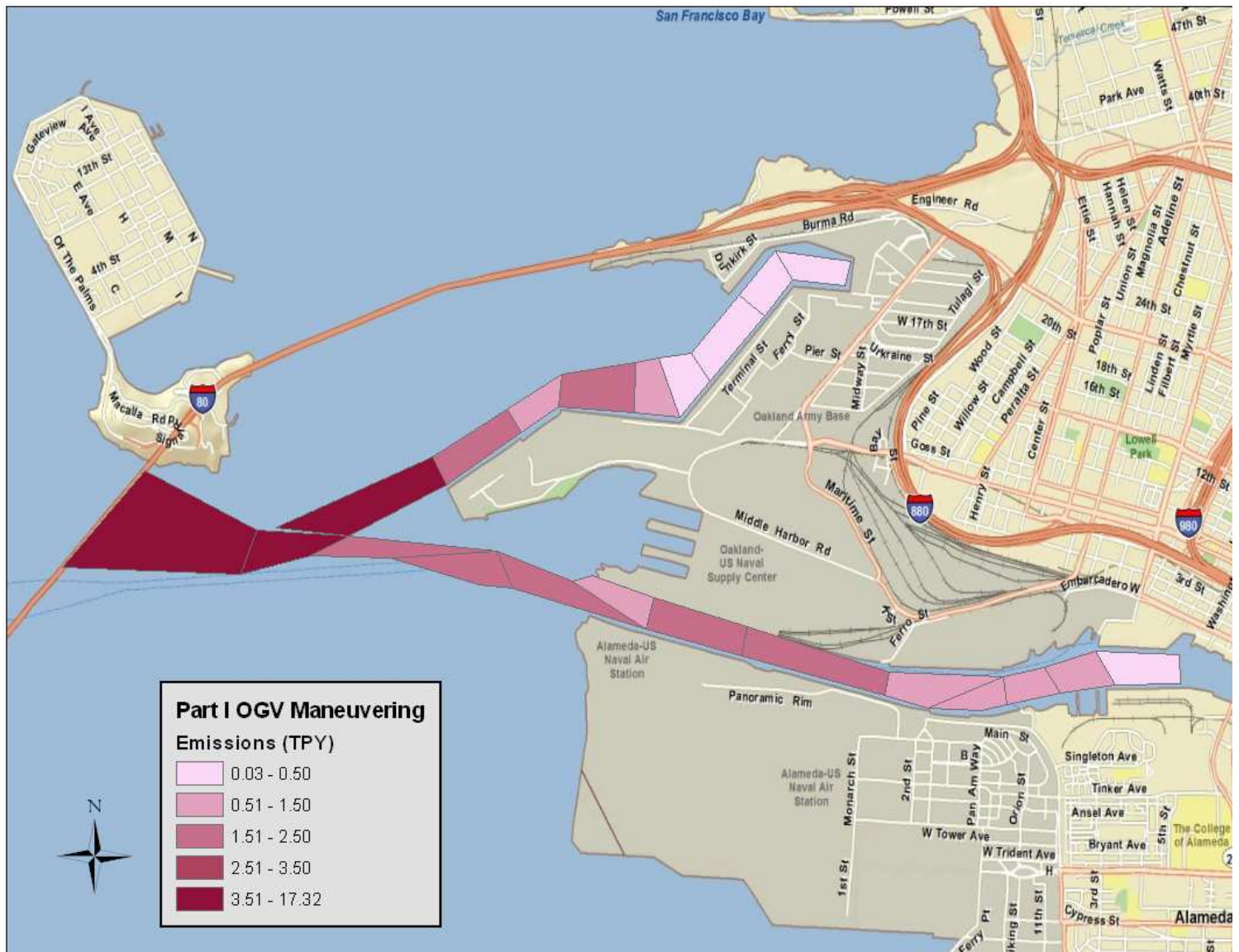
Plot E.3: BNSF Railyard Emission Distribution for Part I



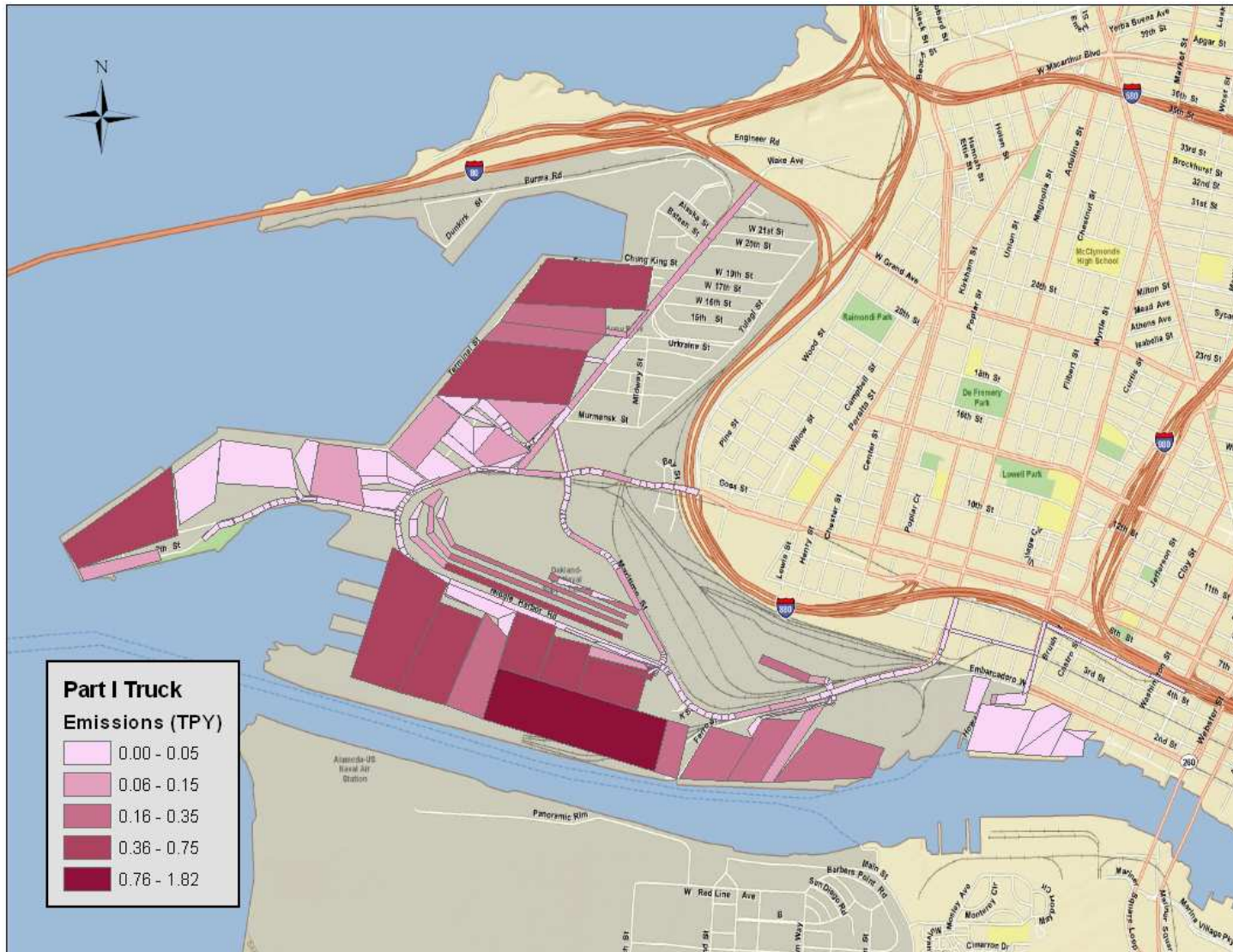
Plot E.4: Ocean Going Vessels (Transiting) Emission Distribution for Part I

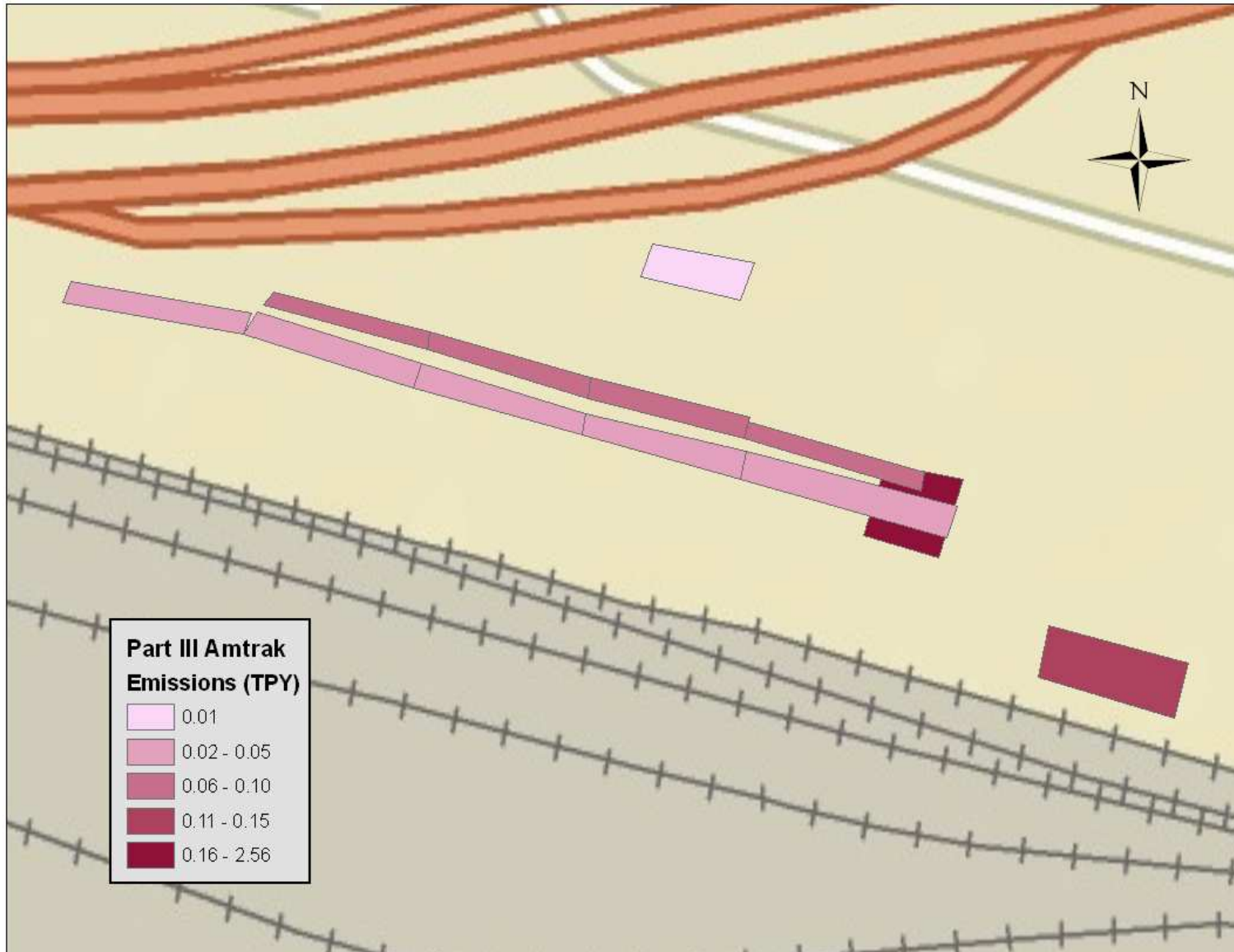
Plot E.6: Port of Oakland Truck (Street & Terminals) Emission Distribution for Part I



Plot E.7: UP Rail Yard Emission Rates for Part II



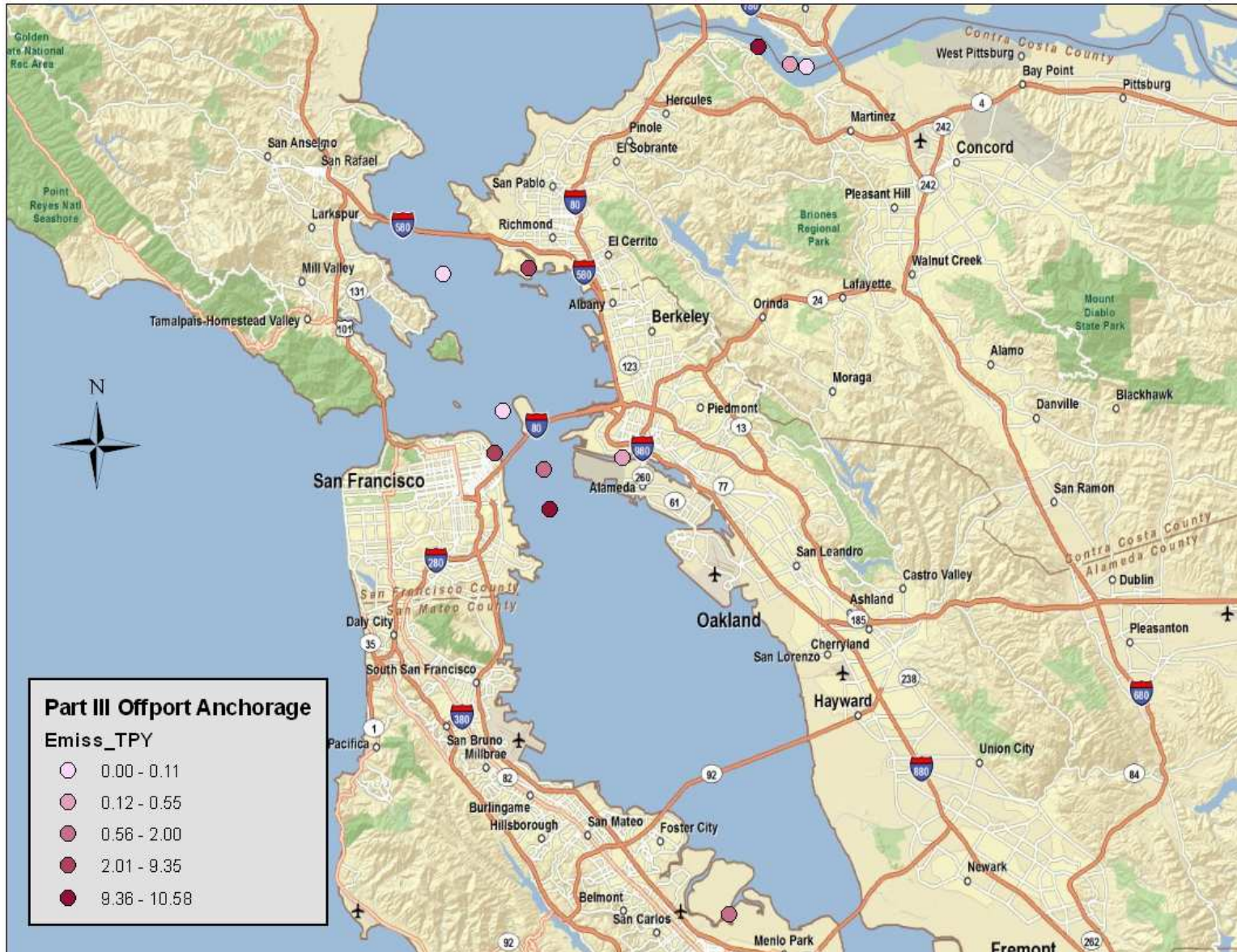
Plot E.8: Amtrak Emission Distribution for Part III



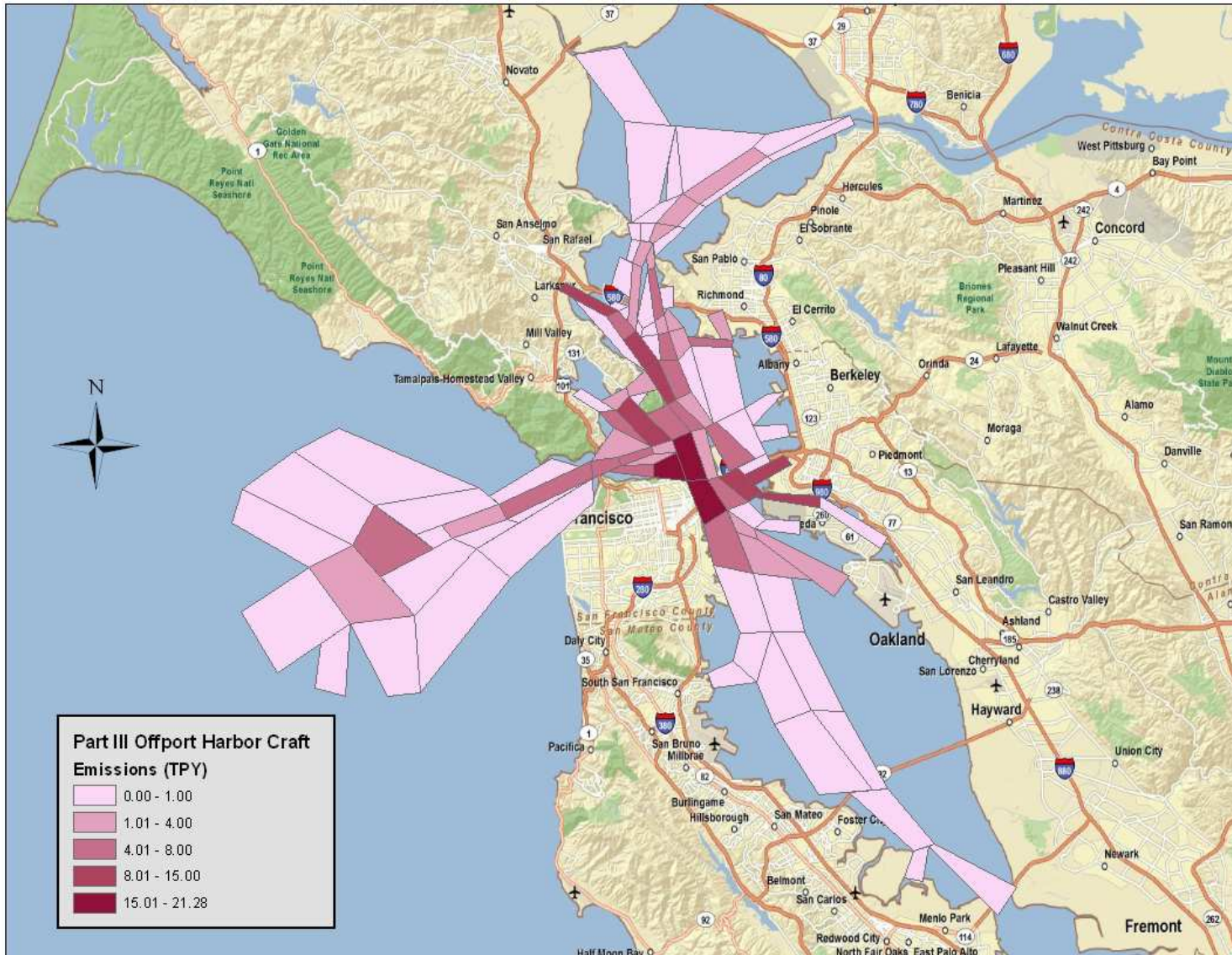
Plot E.9: Off-port Rail Emission Rates for Part III



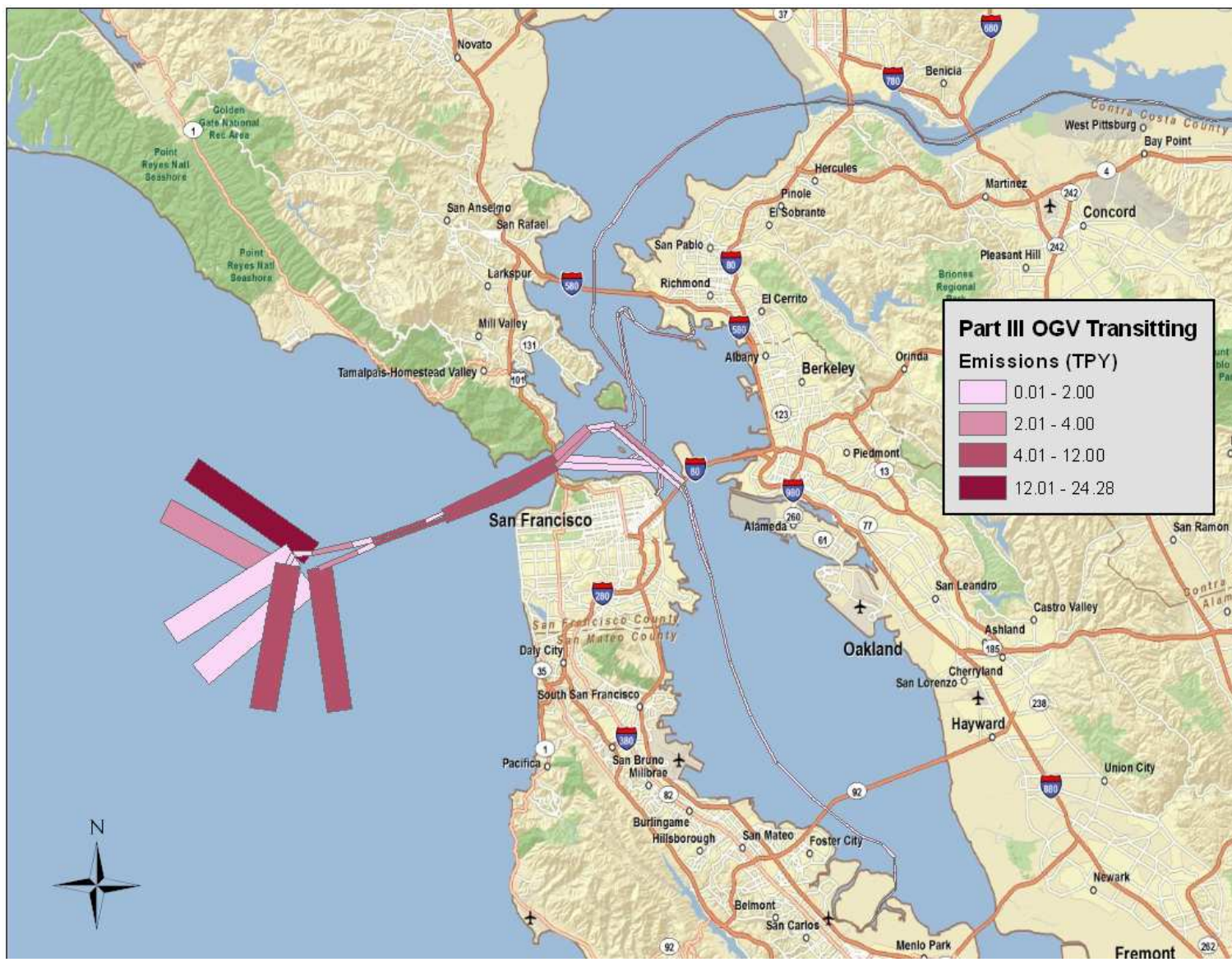
Plot E.10: Off-port Anchorage Emission Distribution for Part III



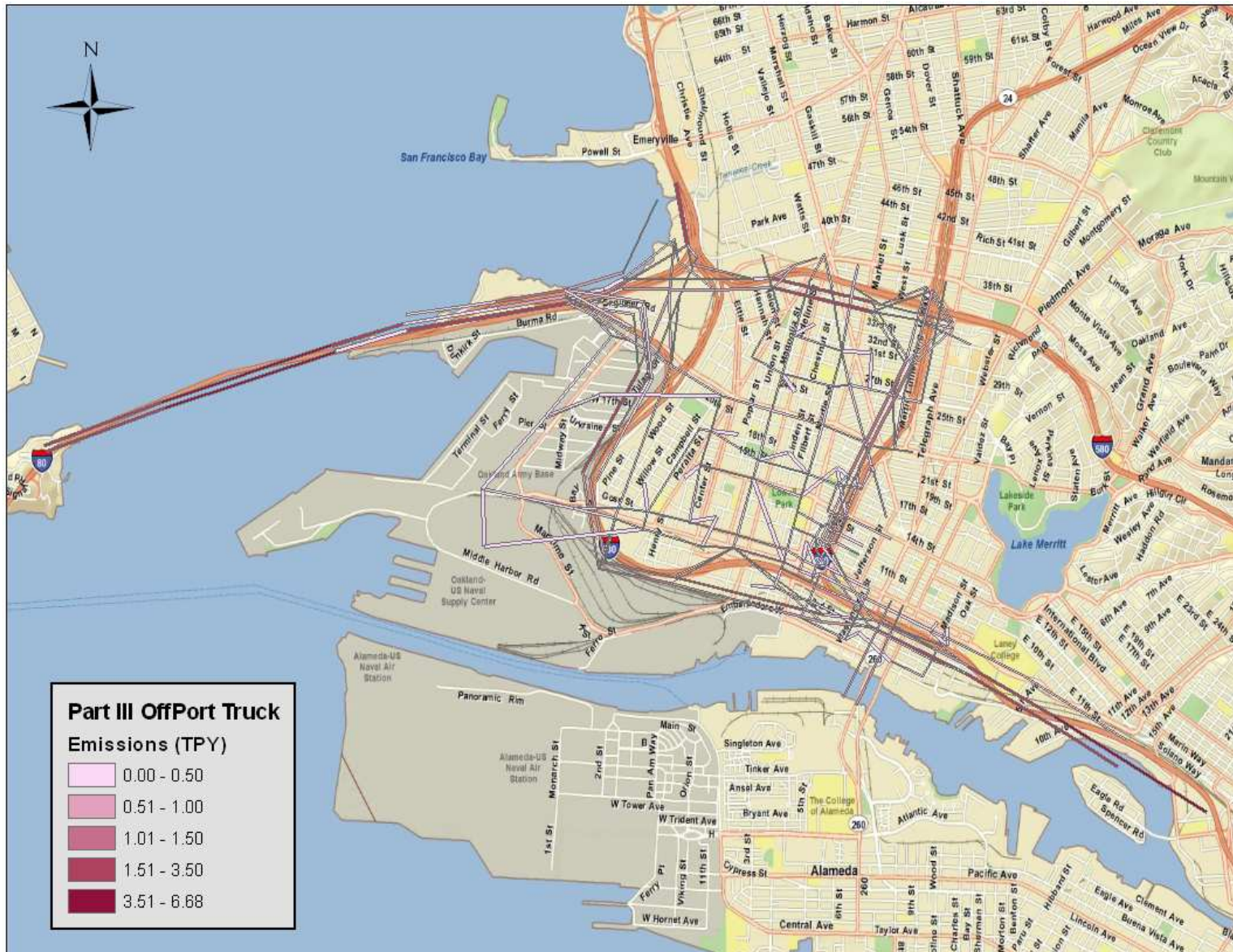

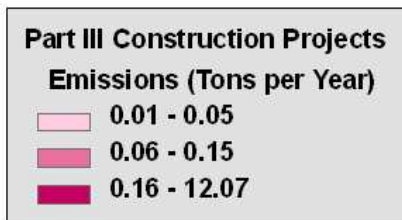
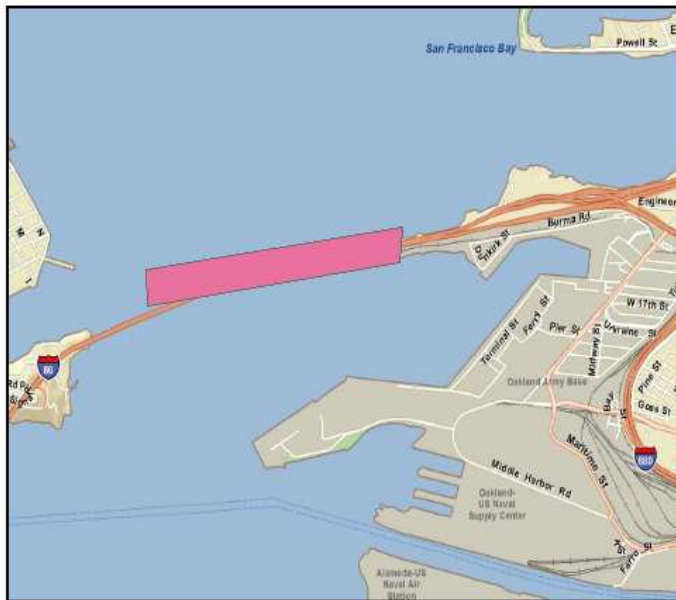
Plot E.12: Ocean Going Vessels Transiting Emission Distribution for Part III
