SUBJECT: REVISED MAIL-OUT #12-14: FIRST PUBLIC WORKSHOPS ON THE DEVELOPMENT OF THE IN-USE OFF-ROAD MOBILE AGRICULTURAL EQUIPMENT REGULATION

The California Air Resources Board (ARB) invites you to participate in the first set of public workshops to discuss developing a strategy for reducing emissions from in-use off-road diesel mobile agricultural equipment with engines greater than 25 horsepower (mobile ag regulation). Meeting Information and Background

On July 26, 2007, ARB adopted a regulation to reduce diesel particulate matter and oxides of nitrogen (NOx) emissions from in-use off-road heavy-duty diesel vehicles in California. Equipment that was used solely for agricultural operations or forestry operations was exempt from the requirements of this regulation. Agricultural equipment includes, but is not limited to, tractors, harvesters, combines, balers, sprayers, forklifts, and all-terrain vehicles owned and/or operated by growers, producers, custom operators, first processors, and rental/leasing companies. Just as in other off-road applications, diesel agricultural equipment can remain in use for long periods of time. This long life means that equipment with new lower emitting engines are introduced into fleets relatively slowly with a direct impact on the pace that emission reductions materialize.

In the 2007 State Implementation Plan, ARB committed to bring a measure for cleaner in-use agricultural equipment to the Board by 2013 with the goal of the measure being to accelerate fleet turnover to equipment with engines meeting the cleanest new engine NOx standard as quickly as possible.

The purpose of these first workshops is to begin the formal public dialogue on effectively achieving emission reductions from the category of agricultural equipment including discussing the expected timeline and the public process for rule development. Staff will also be providing information on updates to the mobile agricultural emissions inventory and the economic analysis that is being developed to help create a regulatory strategy. Staff's presentation will be followed by an opportunity for public comment and discussion. We welcome your participation in this effort.
