DMS – Continues to Grow

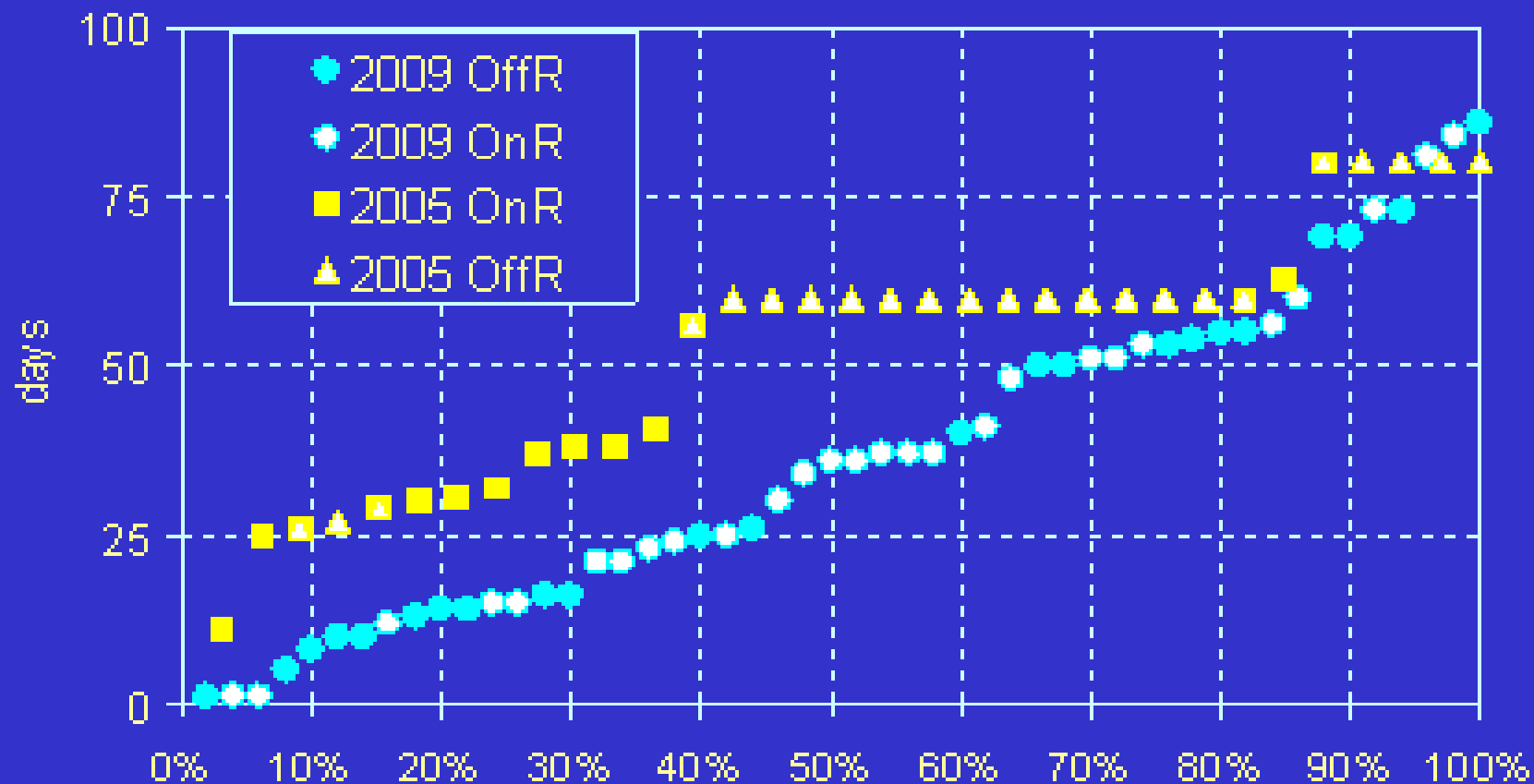

Ways to Speed Up the Process

- Provide all necessary data and documents together
- Upload documents in appropriate folders
- Follow file and process naming convention
- Enter complete and correct metadata
- Get ready for e-cert data submission

E-Cert Update

OFCI and On-Road HD

- Applies to OFCI and on-road HDDE and MDDE
- 2008 worked successfully with EMA on data requirements – copy provided to EPA
- Schema Workshop: August 2009
- Voluntary E-Cert test: February 2010
- Database ready: October 2010
- MY 2011 = E-Cert optional
- MY 2012 = E-Cert required

E-Cert Update

Additional Roll-outs

- SORE
 - Begin data requirement September 2009 and finalize by April 2010
 - Work with EMA / EPA to finalize data requirements
 - MY 2013 = E-Cert required
- LSI / SIME / HD-Otto
 - Begin data requirements about one year after SORE
 - Work with EMA/ EPA to finalize data requirements
