Pursuant to the authority vested in the undersigned by Health and Safety Code Sections 39515 and 39516 and Executive Orders G-45-3 and G-45-4;

IT IS ORDERED AND RESOLVED: That 1982 model-year Nissan Motor Company, Ltd. exhaust emission control systems are certified as described below for diesel-powered light-duty trucks.
