IT IS ORDERED AND RESOLVED: That 1984 model-year Honda Motor Co., Ltd. exhaust emission control systems are certified as described below for four stroke gasoline-powered motorcycles:

Vehicle models and transmissions are listed on attachment. This Executive Order only applies to motorcycles manufactured prior to July 1, 1984. Motorcycles manufactured after June 30, 1984, must meet the 1.0 grams per kilometer hydrocarbon exhaust emissions standards.

BE IT FURTHER RESOLVED: That the listed vehicle models also comply with "California Evaporative Emission Standards and Test Procedures for 1978 and Subsequent Model Gasoline-Powered Motor Vehicles".

BE IT FURTHER RESOLVED: That these motorcycles are found exempt from compliance with the Air Resources Board's "Specifications for Fill Pipes and Openings of Motor Vehicle Fuel Tanks" pursuant to Executive Order G-70-16-E.
