BE IT FURTHER RESOLVED: That these motorcycles are found exempt from compliance with the Air Resources Board's "Specifications for Fill Pipes and Openings of Motor Vehicle Fuel Tanks" pursuant to Executive Order G-70-16-E. HONDA MOTOR CO., LTD.

Vehicles certified under this Executive Order must conform to all applicable California emission regulations.
