EXECUTIVE ORDER M-45-1
Relating to Certification of New Motorcycles

INDEPENDENCE EXPRESS, INC.

Pursuant to the authority vested in the Air Resources Board by the Health and Safety Code, Division 26, Part 5, Chapter 2; and,

Pursuant to the authority vested in the undersigned by Health and Safety Code Sections 39515 and 39516 and Executive Order G-45-9;

IT IS ORDERED AND RESOLVED: That 2000 model-year Independence Express, Inc. exhaust emission control systems are certified as described below for four-stroke gasoline-powered motorcycles:

BE IT FURTHER RESOLVED: That the listed vehicle models also comply with "California Evaporative Emission Standards and Test Procedures for 1978 Through 2000 Model Motor Vehicles."


