**BE IT FURTHER RESOLVED:** That the listed engine models are conditionally certified subject to the following conditions: (1) The manufacturer must perform a confirmatory test for this engine family and report the test results to ARB by November 30, 2011; (2) each confirmatory test result specified in condition (1) must demonstrate that the engine complies with applicable standards.

Engines certified under this Executive Order must conform to all applicable California emission regulations.

This Executive Order is only granted to the engine family and model-year listed above. Engines in this family that are produced for any other model-year are not covered by this Executive Order.
