IT IS ORDERED AND RESOLVED: That Nissan Diesel Motor Company, Limited 1976 model-year diesel-powered engines in heavy-duty vehicles are certified for the engine family described below:

Section 43200, Part I, Division 26 of the California Health and Safety Code requires that the manufacturer affix a decal to the side window to the rear of the driver or, if there is no such window on the driver's side, to the windshield of the motor vehicle.
