IT IS ORDERED AND RESOLVED: That the following Mack Trucks, Inc. 1981 model-year diesel engines are certified for use in motor vehicles with a manufacturer's gross vehicle weight rating greater than 8500 pounds:

The decal shall display the applicable model year heavy-duty engine exhaust emission standards and the following certification emission values:
