Pursuant to the authority vested in the undersigned by Sections 39515 **and 39516** of the Health and Safety Code and Executive Order G-45-3;

IT IS ORDERED AND RESOLVED: That the following International Harvester Company 1982 model-year diesel engines are certified for use in motor vehicles with a manufacturer's gross vehicle weight rating greater than 8500 pounds:

Section 43200, Part 5, Division 26 of the California Health and Safety Code requires that the engine manufacturer furnish a decal with each engine sold or delivered to a vehicle manufacturer. The decal shall display the applicable model year heavy-duty engine exhaust emission standards and the following certification emission values:

Engines certified under this Executive Order must conform to all applicable California emission regulations.
