IT IS ORDERED AND RESOLVED: That the following International Harvester Company 1984 model-year diesel engines have shown compliance with the optional transient standards and are certified for use in motor vehicles with a manufacturer's gross vehicle weight rating greater than 8500 pounds:

The decal shall display the applicable model-year heavy-duty engine exhaust emission standards and the following certification emission values:
