EXECUTIVE ORDER A-6-483 Relating to Certification of New Heavy-Duty Motor Vehicle Engines

GENERAL MOTORS CORPORATION

Pursuant to the authority vested in the Air Resources Board by Sections 43100, 43102 and 43103 of the Health and Safety Code; and

Pursuant to the authority vested in the undersigned by Sections 39515 and 39516 of the Health and Safety Code and Executive Order G-45-3;

IT IS QRDERED AND RESOLVED: That the following General Motors Corporation 1990 model-year gasoline engines are certified for use in motor vehicles with a manufacturer's gross vehicle weight rating (GVWR) of 8,501 to 14,000 pounds for which the sales of engines certified for these engine families for use in motor vehicles of 8,501 to 14,000 pounds GVWR shall not exceed five percent (5%) of the manufacturer's total California sales of engines used in motor vehicles in this GVWR category:

The manufacturer has elected to certify those engines used in motor vehicles of 8,501 to 14,000 pounds GVWR to emission standards for engines used in motor vehicles over 14,000 pounds GVWR in accordance with 40 CFR 86.088—10(a)(3)(i). The manufacturer will use Tune-Up Label statements in accordance with California Motor Vehicle Tune-Up Label Specifications and will submit final California sales figures within 60 days after the end of production.
