EXECUTIVE ORDER A-328-27

Relating to Certification of New Heavy-Duty Motor Vehicle Engines

IMPCO TECHNOLOGIES, INC.

Pursuant to the authority vested in the Air Resources Board by Sections 43100, 43102 and 43103 of the Health and Safety Code; and

Pursuant to the authority vested in the undersigned by Sections 39515 and 39516 of the Health and Safety Code and Executive Order G-45-9;

IT IS ORDERED AND RESOLVED: That the following engine and emission control system produced by the manufacturer are certified for use in heavy-duty vehicles with a manufacturer's gross vehicle weight rating (GVWR) greater than 14,000 pounds:

BE IT FURTHER RESOLVED: That the listed engine models are certified to the optional lower-emission NOx standard listed above pursuant to Title 13, California Code of Regulations, Section 1956.8(a)(1).


BE IT FURTHER RESOLVED: That for the listed engine models, the manufacturer has submitted the materials to demonstrate certification compliance with the Board's emission control system warranty provisions (Title 13, California Code of Regulations, Section 2035 et seq.).

BE IT FURTHER RESOLVED: That the listed engine models comply with the "California Motor Vehicle Emission Control and Smog Index Label Specifications" for the aforementioned model year (Title 13, California Code of Regulations, Section 1965).

Engines certified under this Executive Order must conform to all applicable California emission regulations.
