Relating to Approval of New Motor Vehicles

Pursuant to the authority vested in the undersigned by Sections 39150 and 39151 of the Health and Safety Code; and

Pursuant to the authority vested in the undersigned by Section 39023 of the Health and Safety Code;

IT IS ORDERED AND RESOLVED: That Ford Motor Company canister storage type fuel evaporative emission control systems are approved for the 1974 model-year heavy-duty gasoline powered vehicles described below:
